

- (c) If this "Summons" and the other court papers were personally served on you, your "Response" or "Answer" must be filed within **TWENTY (20) CALENDAR DAYS** from the date you were served, not counting the day you were served. If this "Summons" and the other papers were served on you by mail, your Response must be filed within **THIRTY (30) CALENDAR DAYS** from the date posted.
