## Governance:

- 1. The Installer must have a current Ontario BCIN registration number at the time of module installation.
- 2. Installations must take place within the province of Ontario, Canada.
- Installations must be completed under the specifications of a valid Building Permit as required by the current version of the Ontario Building Code or the specifications of a valid Environmental Compliance Approval issued by the Ontario Ministry of Environment.
- 4. Modules must be ordered from Cromar Environmental and received between January 1, 2025, and December 15, 2025, at 5:00 PM Eastern Standard Time.
- 5. Modules must be installed between January 1, 2025, and December 19, 2025, at 5:00 PM Eastern Standard Time.
- 6. Modules must be paid for **in full** between January 1, 2025, and December 19, 2025, at 5:00 PM Eastern Standard Time.
- 7. Installers must approve the use of their company name in the marketing of this promotion.
- 8. 1 draw ticket per Eljen GSF module (i.e., 30 module order = 30 draw tickets).
- 9. Draw ticket has no cash value.

- 10. Modules must be ordered from Cromar Environmental and installed and paid for in full prior to the draw ticket being issued to the installer and the ticket being placed into the barrel.
