

AN ORDINANCE PROVIDING FOR THE ANNEXATION  
OF CERTAIN UNINCORPORATED AREAS

Ordinance No. 10.827

WHEREAS, a verified petition was presented to the Board of Trustees of the Village of St. Elizabeth requesting annexation of the following described tract:

The East part of the Southeast quarter of the Southwest quarter of Section 28, Township 41 North, Range 12 West of the 5<sup>th</sup> Principal Meridian, described as follows: Beginning at the quarter section corner to Sections 28 and 33; and running North 15.80 chains to a conditional corner; thence North 60 degrees 30' West 5.20 chains to center of branch; thence up and along the branch to a point 10.50 chains West of the point of beginning; thence East to the point of beginning.

WHEREAS, said petition is found to have been signed by the owners of record to said property, namely Leonard J. Doerhoff and Cyrilla A. Doerhoff; and

WHEREAS, a verified petition was presented to the Board of Trustees of the Village of St. Elizabeth requesting annexation of said property; and

WHEREAS, the Board of Trustees finds that said property is contiguous to the existing corporate limits of the Village of St. Elizabeth; and

WHEREAS, a public hearing was held on Jan 7, 2010, which date was not less than fourteen nor more than sixty days after said petition was received; and

WHEREAS, prior notice of said public hearing was published in the Autogram-Sentinel, a newspaper of general circulation in Miller County, Missouri, said publication being more than seven days prior to the public hearing as required by Section 71.012(2), RSMo 2000; and

WHEREAS, at said public hearing evidence was presented regarding the proposed annexation; and

WHEREAS, no written objection to the proposed annexation was filed with the Board of Trustees within seven days of said public hearing; and


WHEREAS, the Board of Trustees now convenes at a duly called meeting for the purpose of acting upon the annexation request.

Now, therefore, be it ordained by the Board of Trustees of the Village of St. Elizabeth, Missouri, as follows:


1. That the proposed annexation is reasonable and necessary to the proper development of the Village of St. Elizabeth.
2. That the Village of St. Elizabeth has the ability to furnish and will furnish normal municipal services of the Village to said property within a reasonable time after this date.
3. That said property is hereby annexed to the Village of St. Elizabeth and the corporate limits are extended to include said area within the municipal boundaries.
4. That the Village Clerk shall cause three certified copies of this ordinance to be filed with the Clerk of Miller County, whereupon the annexation shall be complete and final, all as provided in Section 71.012, RSMo 2000.
