### Ordinance No. 17-839

### AN ORDINANCE ESTABLISHING SCHOOL TRAFFIC ZONES

### **General Provisions**

- A. Pursuant to Ordinance No. 17-839, the Village of St. Elizabeth determined to establish a school zone in the area of St. Elizabeth School R-IV ("School Zone"), as further defined below;
- B. The Ordinance will establish designated speed limits for the School Zone which will be posted by signage in compliance with state regulations. The Ordinance will also establish a penalty for the violation of the same.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF ST. ELIZABETH, MISSOURI, AS FOLLOWS:

- 1. **Location.** The School Zone shall be within the following locations;
- a. Beginning at the intersection of Walnut Street/Hwy 52 and Church Street and continuing northeast on Church Street in front of the school and ending at Jefferson Street; and
- b. Beginning at the intersection of Franklin Street and Hwy 52 and continuing southeast on Franklin Street to the intersection of Franklin Street and Church Street.
- 2. **Speed Limit.** The reduced speed limit within the School Zone shall be 20 mph on school days or when children are present. Reckless and imprudent driving within the School Zone is also prohibited.
- 3. **Signage.** Signage in compliance with applicable state regulations shall be installed and/or maintained to indicate the presence of the School Zone and the reduced speed limit in effect.
  - 4. **Violation.** A person who violates the speed limit and/or this Ordinance shall be

guilty of the applicable Missouri State Law and/or a Class C Misdemeanor. A violation of this Ordinance is punishable by a fine of up to \$500. This Ordinance may be enforced by the Miller County Sheriff's Department and/or other state law enforcement agencies.

- 5. **Date of Effect.** This Ordinance shall become effective immediately upon adoption or as soon as signs are in place.
- 6. **Severability.** If any provision of this Ordinance is found by a court of competent jurisdiction to be void or unenforceable, such void or unenforceable provision shall be severed as though it never formed a part of this Ordinance, and all other provisions hereof shall remain in full force and effect.
