

AN ORDINANCE ESTABLISHING BASIC RATES IN THE VILLAGE OF ST. ELIZABETH, MISSOURI, FOR WATER SERVICE FROM THE MUNICIPAL WATERWORKS.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF ST. ELIZABETH, MISSOURI, AS FOLLOWS:

Section 1. The rate for water service to residential customers of the waterworks to be constructed by the Village of St. Elizabeth, Missouri, shall be as follows:

First 1, 000 gallons	\$4. 50 minimum
Next 1, 000 gallons	2. 50
Next 1, 000 gallons	1. 00
Next 1, 000 gallons	. 75
All over 4, 000 gallons	. 50

Section 2. The rate for water service to commercial customers of the waterworks to be constructed by the Village of St. Elizabeth, Missouri, shall be as follows:

First 1, 000 gallons	\$9. 00 minimum
Next 1, 000 gallons	2. 50
Next 1, 000 gallons	1. 00
Next 1, 000 gallons	. 75
All over 4, 000 gallons	. 50

Section 3. Water users signing water user agreements on or prior to the date of bid-letting shall be required to pay a preinstallation connection fee of \$25. 00. Water users signing water user agreements after the date of bid-letting shall be required to pay a preinstallation connection fee of \$125. 00 or actual cost whichever is greater subject to adjustment as per Rule 18 of the Rules and Regulations of the Municipality. All water users shall be required to pay a meter deposit of \$10. 00 in addition to the above connection fee, subject to adjustment as per Rule 20 of the Rules and Regulations of the Municipality. Water users shall be required to pay the cost of making the connection from the meter to the user's building. Failure of the user to make such connection within 30 days from the installation of the meter connection shall result in forfeiture of both the connection fee and meter deposit. In addition to the charges for reconnection computed in accordance with Rule 14 of the Rules and Regulations, there shall be a reconnection fee of \$25. 00 paid for such reconnection.

Section 4. That all ordinances or parts of ordinances conflicting with the pro-

visions of this ordinance are hereby repealed insofar as the same affect this ordinance.
