

## **GROVE FARM JFC:- REGISTRATION OF PLAYERS TERMS AND CONDITIONS SEASON 2025/26**

**On the registration form please answer yes or no to the following consents below.(If you answer no to League Registration it will mean your child cannot play league games).**

**LEAGUE REGISTRATION CONSENT:-** I consent to my child being registered with the Nuneaton and Bedworth Minor Football League and/or The Coventry and Warwickshire Youth league and/or the Mid Warwickshire Youth League and/or The Midland Junior Premier League, in the season 2025/26, as a member of Grove Farm Pavilion JFC and be bound by the Rules and Regulations of the league, The Birmingham County FA and The Football Association. (All player registrations expire on the last day of the season)

I understand that whilst registered as a member of the club, my child is not permitted to play football for any other club in that league.

I consent to the transfer of misconduct information and any reasonable personal details between this League and Birmingham County Football Association.

I understand that my child's data will be held securely within the FA's Whole Game System and within the Clubs secure website server. ( maintained by Go Daddy).

I will ensure that any support towards my child will be for encouragement only and, at all times, match officials and opponents will be treated with due respect. The decisions of the match officials will be accepted without protest.

We have read and, understood the Players and Parents FA Codes of Conduct.(These can be found on our website under club documents). and I and my child agree to abide by them. I understand that failure to comply with this declaration may affect my child's eligibility to play in the league and be a member of the club. ,

**IMAGE CONSENT :-** I give permission for my child's image **ONLY** to appear on the club website / social media platforms/cup programme including if I leave the club/league. My child is not subject to a court order. ( If they are please answer no to image consent on the registration form and inform your manager. The club needs to know this so adequate protections can be put in place with regards to images being taken at other venues )

**MEDICAL CONSENT:-** I agree to my child receiving medication as instructed and, in an emergency, when I am not present, any emergency dental, medical or surgery treatment, including anaesthetic or blood transfusion, as considered necessary by medical professionals present.

On the registration form you will then be asked to provide names and numbers of 2 Emergency Contacts and asked about any medical conditions that requires treatment, any regular medication being taken or if your child is allergic to any medication. If you answer yes to any of these questions please provide brief details.

**Please answer honestly. In the majority of cases your child will still be able to play football. Your manager needs to know to protect your child and them. All information is kept strictly confidential.**

**Eye Wear** Due to an injury to a young player in Manchester, it is recommended although not statutory, that players who wear eyewear, wear sports goggles for matches/training. If you choose for your child to wear eye wear for matches/training, this on the understanding that you have full responsibility for this decision and Grove Farm Pavilion JFC cannot accept any responsibility for any injuries sustained.
