Private Event Rental Fee: The cost to rent the indoor and/or outdoor garden venue is \$150/hr. + tax (3 hr. minimum) - you must include your setup & breakdown time in cost). Each event rental includes an folding rectangle tables with seating for up to 50 guests, lighting, surround sound outdoor speakers, use of restroom, and plant green screen setup. DEPOSITS & CANCELLATIONS

To secure scheduling, a non-refundable deposit of 50% is mandatory. The remaining balance must be settled in full on the day PRIOR to the event. In case of cancellation, refunds will only be issued for the amount paid excluding the non-refundable deposit. Should you need to cancel, a minimum 30-day notice is required to receive a refund on amounts paid in excess of the non-refundable deposit. Cancellations made with less than 30 days' notice will result in forfeiture of all funds.



WEATHER

We provide an indoor/outdoor garden experience for our venue rental guests. There are no refunds due to weather except those that cause emergency closure. For non-emergency weather related incidents, rescheduling is available as an alternative option.

OUTSIDE VENDORS & FOOD TRUCKS

If you would like to bring in outside vendors you MUST have approval prior to the day of the event. Each outside vendor will need to be approved by Pinelands Management, and be licensed and insured. No exceptions. (No Food Trucks as we have one on site)



ALCOHOL

Is only permitted in the nursery to those who are 21 and up. It is the responsibility of the client to make sure that all of your guests obey local alcohol laws.



PARKING

Parking is located in front of Pinelands Nursery. We do have overflow if needed. No vehicles (including vendor vehicles) may be left in the parking lot overnight. Vehicles left overnight are subject to being towed at owners expense.



SETUP & CLEANUP

Anyone attending the event (this includes all guests and vendors) must exit the grounds no later than the reserved / contracted time. The actual setup, takedown, and cleanup is the client's responsibility and must be factored into the total venue rental time, minus chairs and tables. If cleanup is required by Pinelands, it will result in additional charges of \$125/hr to your debit/credit card on file. Any items (decorations, arbors, extra tables etc.) used for your event may not be left overnight.



FORCED CLOSURE

Neither party will be liable for any failure or delay in event due to causes beyond our control. Acts of God, natural disasters, fire, etc



DAMAGE

I acknowledge that I will be fully responsible for any damage to the venue or its property that occurs during the rental period. I agree to cover the costs of any repairs or replacements required as a result of such damage.

VENUE RENTAL OVERVIEW

Dining / Event Space



- Seating at the tables that can accommodate up to 50 guests.
- Outdoor Bistro Lights or indoor lights in Greenhouse
- Use of outdoor surround sound speaker system with access to your own play list through Spotify
- Use of electrical outlets (must provide your own extension cords)
- Use of Restrooms
- Use of Trash Cans
- All access to nursery and Garden Cafe as needed.
- Food Truck is a separate business but can be open upon discussion.

Plant / Green Screen Setup



A variety of green plants and shrubs are positioned, with intention, throughout the venue, creating a magical and whimsical garden experience. We will do our best to accent with foliage and flowers to compliment event themes. This is based on availability of plants currently situated on the nursery grounds at the time of event. If additional, or specific plants requested, a plant rental will be an added expense.

Decorations



Pinelands does not decorate, however decorations are allowed. The Bloom Shoppe can be hired to decorate the venue with florals. Please discuss and confirm all decoration ideas at booking. Please also secure the necessary time to accommodate setup, breakdown and cleanup. Please no use of Command Strips or anything that will leave behind a sticky residue. Please no use of silly string, glitter, confetti, rice, or anything that could be potentially harmful to the plants or wildlife in the garden. Please no use of flamed candles.

Food, Beverage & Alcohol



Outside vendors are permitted, including alcohol, however all vendors must be licensed and insured. A waiver will need to be signed agreeing that only those who are 21 and over will be allowed to consume alcoholic beverages on property. It is the responsibility of the contractee, to ensure that all guests obey local alcohol laws. Food Truck on site but they book separately.

Venue Rental Cost



Starts at \$450+tax (3 hour minimum). Each additional hour is \$150/hour. Set-up and breakdown time must be included in your calculated rental time. Private venue waiver will need to be signed and returned with a 50% nonrefundable deposit in order to reserve your after-hours venue space. The remaining balance for the event rental is due prior to and no later than the start of the event.

The Bloom Shoppe offers a variety of flowers arranged in an a la carte setting with the assistance of a florist to help guide you through the bouquet or arrangement making process. This is great for bridal parties, baby showers or even children's birthday parties.

Pricing and Payment



Workshops start at \$55 per person depending upon activity and number of people attending.



After-hours Workshops are an added experience to your Event Rental and are priced separately

All workshops and activities must be paid in full when paying the deposit for the Event Rental as this is needed to ensure all the proper materials are sourced and available for your event. There are NO refunds on Workshop activities as all material will be purchased specifically for your event based on your number of attendees and to cover all staffing scheduled for your event. Reservations can be re-scheduled in accordance with our policies stated on page 2 of this agreement. Workshops in conjunction with a party are highly recommended to be scheduled for a minimum of 3 hours to accommodate the time to enjoy both your party and activity.
