24 What is a person called who is afflicted with tzaraas?

**14:2 "...the metzora."**

**המצרע**

15 If a Kohen declares a metzora's tzaraas is healed, what items must he use to become pure again?

**14:4 "...two live, clean birds, cedar wood, crimson thread, and hyssop."**

**שְׁתֵּי-צִפְרִים חַיִּים טְהוֹרוֹת וְעֵץ אֶרֶז וְשָׁנִי תוֹלַעַת וְאַזְב**

2 What shall be done with one of the birds?

**14:5 "...one bird shall be slaughtered into an earthenware vessel over spring water."**

**וְשַׁחַט אֶת-הַצִּפּוֹר הָאֶחָד אֶל-כְּלִי-חֶרֶשׁ עַל-מַיִם חַיִּים**

6 What shall be done with the live bird?

**14:6 "...dip... into the blood of the bird that was slaughtered over the spring water."**

**וְטָבַל .... בְּדַם הַצִּפּוֹר הַשְּׁחֻטָה עַל הַמַּיִם הַחַיִּים**

23 What else shall be dipped into the blood of the slaughtered bird?

**14:6 " the "Eitz HaErez, the "Shnei HaTolat", and the "Eizov"**

16 What shall be done with the items that were dipped in blood?

**14:7 "Then he shall sprinkle seven times upon the person being purified from tzaraas..."**

3 What will the Kohen do to the metzora through this process?

**14:7 "he shall purify him."**

20 What shall the person being purified do after this process?

**14:8 "...shall immerse his clothing, shave off all his hair, and immerse himself in the water..."**

8 Can the purified person enter the camp right away?

**14:8 "...he shall enter the camp but he shall dwell outside of his tent for seven days."**

12 What hair does the purified metzora need to shave again on the seventh day?

**14:9 "... he shall shave all his hair, on his head, his beard, his eyebrows ...all his hair"**

5 The Kohen takes the person and what else on the eighth day?

**14:10 "2 unblemished male lambs, 1 unblemished ewe...three tenth-ephah solet... 1 log of oil"**

**שְׁנֵי-כִבְשִׂים תְּמִימִים וְכִבְשָׂה אַחַת בַּת-שָׁנָה תְּמִימָה וְשִׁלְשָׁה עֶשְׂרִינִים סֹלֶת מִנְחָה בְּלוּלָה בְּשֶׁמֶן וְלֹג אֶחָד שֶׁמֶן**

**14:21 "If he is poor and his means are not sufficient..."**

- 9 Why shall the Kohen place oil on the head of the Metzora who is becoming Tahor?  
**14:29 "to provide him atonement before Hashem."**

- 21 What needs to be done before the Kohen will inspect a house for tzaraas?  
**14:36 "...they shall clear the house before the Kohen comes..."**  
**וּפְנֵי אֶת־הַבַּיִת בְּטָרִם יָבֵא הַכֹּהֵן**
- 17 What did the Kohen see for him to instruct that the house needs to be quarantined for 7 days?  
**14:37 "...the affliction is in the walls of the house...deep greens or deep reds..."**  
**הַנֶּגַע בְּקִירַת הַבַּיִת שֶׁקָּעָרוֹרֵת יִרְקָקֶת אוֹ אֲדָמָדָמַת**
- 4 If after the 7 days the Kohen sees that the "nega" has spread in the walls, what will he say?  
**14:41 "...the house shall be scraped on the inside, all around..."**

- 22 What shall they do to the house after it is scraped out?  
**14:42 "They shall take other stones and bring them in place of the stones..."**  
**וְלָקְחוּ אֲבָנִים אַחֲרוֹת וְהִבִּיאוּ אֶל־תַּחַת הָאֲבָנִים**
- 25 How will the Kohen know the house has tzaraas after they have replaced with new stones?  
**14:44 "...the affliction has spread in the house (again)..."**  
**וְהָנָה פֶּשֶׁה הַנֶּגַע בַּבַּיִת**
- 1 What will the Kohen say to do to the house that is tamei with tzaraas?  
**14:45 "He shall demolish the house...and take it outside the city to a tamei place"**  
**וְנָתַץ אֶת־הַבַּיִת .... וְהוֹצִיא אֶל־מַחוּץ לְעִיר אֶל־מְקוֹם טָמֵא**
- 10 If after replacing the inside of the house he sees that the "nega" has not spread, what is it?  
**14:48 "...the Kohen shall declare the house to be pure"**  
**וְטָהַר הַכֹּהֵן אֶת־הַבַּיִת**
- 7 How is the blood of the slaughtered bird used in purifying a house after the tzaraas is removed?  
**14:51 "sprinkle it towards the house seven times"**  
**וְהִזָּה אֶל־הַבַּיִת שֶׁבַע פְּעָמִים**
- 19 What is done with the remaining live bird after purifying the house?  
**14:53 "send the living bird to the outside of the city to the open field"**  
**וְשָׁלַח אֶת־הַצִּפּוֹר הַחַיָּה אֶל־מַחוּץ לְעִיר אֶל־פְּנֵי הַשָּׂדֶה**
- 18 How does the Torah summarize the Kohen's responsibility to the Metzora?  
**14:57 " ...to teach about the day of becoming impure and the day of becoming pure".**
