- 1. Debbie pursued obtaining information regarding the slippery pool area. She did find a product that could be used and turned over product information and contractor information for Jonathan (property manager) to have completed before opening of the pool.
- 2. Lock broken on Men's bathroom at pool. Jonathan will have replaced before pool opening.

- 10. There was much discussion regarding By-laws and Declaration of Restrictions. We will be discussing this in our next meeting. It was tabled and will be discussed further at our next meeting. Changes to these documents require legal assistance, not just a vote by homeowners. Jonathan noted that Declaration of Restrictions requires 75% of homeowners and By-Laws require 51% of homeowners. We are researching the possibility of a committee.
- 11. Jonathan will contact the builder about maintain and cleaning up the empty lots.


