- 3. We anticipate having to do a Reserve Study of our Budget as a result of Delaware State Law.
- 4. We discussed with Donna how "re-sale" of existing housing takes place and are the new home owners provided with the ARC and HOA By-Laws. Jonathan stated the Realtor is responsible for providing ARC and HOA By-Laws to the new homeowner. Donna does still

Matt will meet with the board upon the initial setup of the site for approval. He is also looking into providing the board with one (1) email address for home owners to use to contact the board.
