I, Rebecca Parker, am writing this testimony because my father is being threatened with jail time because I am refusing to go back to an abusive household in Rhode Island. He has been trying to force me to go back but I have firmly refused. He would have to physically assault me to make me go back, and if I was forced to go back, I would likely kill myself because that is better than going back to my abusive mother who has done the following.

- She has blamed me for my grandfather's death
- She is monitoring what I do on my phone to the point that if I vent to my friend about an argument we had, she will see who I am saying, come into my room (of which doesn't have a lockable door) and scream at me for venting to my friends
- She has been isolating me in a bed bug and mouse infested house and doesn't allow me to leave

unless I have plans with my friends or need to go to school

- She once got mad at me because I threw up on the bathroom floor instead of in the toilet

- She has destroyed my belongings on multiple occasions, including once when she smashed one of my ceramics and leaving me to clean it up. She also broke chairs and bookshelves on many occasions during or after arguments.

- ~~When~~ a few years ago I wanted to spend Wednesdays into Thursday nights at my dad's house so I wasn't constantly going back and forth between the two places and so I could spend more time with my dad, and when she got home she said, "If you want to go live with your dad so badly go pack your shit in boxes and leave." Thus when I started saying that I didn't want to live with my mom (I don't remember how old I was at the time but I think I was 12 or 13 years old)

- She has forced me to eat things that numerous doctors have said I shouldn't eat and claimed that I was fine when I was tired and sick all the time and barely had the energy to do anything

- I even started hating myself because I was scared of having an allergic reaction to something

- She would yell at me whenever I asked my doctor about the medical conditions I have

- She has directly disrespected my set aside time with dad and my friends, even going so far as to force me off my zoom call with my dad so we could go to Texas Roadhouse on Father's day.

- We got into an argument because she wanted to change my last name to 'Pelopeda' but I didn't agree to it because I liked my last name as 'Parker'

- after an argument when I was younger she locked herself in her room and acted like I didn't exist for 2 weeks

- no house I've lived in has felt safe because they never had working locks and the ones in W. Warwick had very cheap been broken into multiple times

- I was never all that close to Ron (my step-father) and yet she wanted me to match his last name

- My mom has constantly gotten mad at me for playing certain games and watching certain videos, this has lead to a lot of my insecurities and has even built on others

- She has made me miss out on spending time with my friends because we "have plans that day" when said plans consist of doing things she wants to do (AHA: watching Hallmark all day)

- We never had much food in the house (mostly being pasta, cereal and chicken nuggets on rare occasions)

- She has lied to my family and made them turn against me when it came to arguments.

- At one point we got a very active and aggressive puppy and they didn't train him out of his habits. he made me feel unsafe while walking into the house/kitchen/bathroom and he attacked Toby multiple times (even biting off a piece off his ear) and it wasn't until he hurt Nana that they got rid of him.

- She has blocked my family on many occasions because she didn't approve of what I send to my friends and memes I share with my family

- I almost failed a ceramics class because she got mad and threw one of my ungraded ceramics at the wall close to me

- It seemed like whenever I tried to set clear boundaries she would go out of her way to cross them (for example I wanted my room to be my own safe place and I just wanted a lock and privacy but she literally just waked into my room and she said I didn't deserve a lock)

- another situation like that I warned my chat with my friends to be private so she wouldn't come and scream at me whenever I vented to my friends about how she treated me and she did nothing to stop looking at my chat room/text messages

- She signed me up for dance classes and she never even showed up for the parent observations

- She never let me stay for afterschool activities unless they were mandatory or detentions/teacher meetings

- She even threw away the things Dad and Mary would send me in the mail and she never even told me

- She has constantly complained about me and my friends chat rooms and she even went so far as to threaten to delete and destroy all of my stories and chats with my friends

- at one point she hid my xbox device so I couldn't play any games with my family
- She would get mad when I turned off my phone so she couldn't track my location
- She would get mad if I talked to dad without her permission (to the point that I had to sneak around just so I can call him)
- I have even had to cut off zoom meetings with my dad so she doesn't scream at me.
- There have been many occasions where she has done things such as doctor appointments and even trying to force me to get a vaccine without my consent or my dad's knowledge.
- When Buster (the puppy) was biting me mom did nothing about that or the concerns I clearly expressed, she just denied all of it, which made me feel insignificant in my own home.
- There were numerous occasions where she would monitor my phone calls with my dad for example, one time

I thought I was alone in the kitchen talking to dad ~~so~~ only to find out she was listening from outside the kitchen window, and she got mad at me for asking my dad how Texas was - One time my mom got mad at my dad because after a performance I wanted to change out of my suit so dad could take it home, ~~she~~ it ended with me dragging her away because she was cursing in front of little kids

- She blamed me for bringing covid into the house and killing Oompa when in reality I was never sick, she was

- mom tried to use oompa's death as leverage to make me take the covid vaccine that we weren't sure if it would kill me or not

because of my allergies she basically said "if you don't get this vaccine you'll end up ~~ugly~~ like oompa" and I remember thinking that maybe that wouldn't be so bad because my living situation sucked and I was grieving

- During an appointment dad asked my PCP about my PCOS and my mom started screaming for security to get him out.

- She tried to convince me that dad had abandoned me when they moved to Texas when I know that wasn't the case

- I've had to use going to get the mail just so I could talk to my dad in privacy when I shouldn't need to do that for privacy

- At one of my dentist appointments I was getting a brace evaluation and she freaked out and tried to force me to go with her so I couldn't get a medical treatment I needed

- She told me to not go with mary and dad when we were going on vacation ~~there~~ during my time with him.

- My mom has manipulated me into thinking that her treatment of me is nothing so I don't say anything about it




