**ORDINANCE 67, AN ORDINANCE AMENDING ARTICLE II “DEFINITIONS”; ARTICLE III “DISTRICT REGULATIONS”; ARTICLE IV “DISTRICT REQUIREMENTS”; ARTICLE V “GENERAL REQUIREMENTS”; AND ARTICLE VI “ADMINISTRATION” ADOPTED BY ORDINANCE #45, AND ORDINANCE AMENDING KINGSBURY COUNTY ORDINANCE #32, AN ORDINANCE ESTABLISHING ZONING REGULATIONS FOR KINGSBURY COUNTY, SOUTH DAKOTA, AND PROVIDING FOR THE ADMINISTRATION, ENFORCEMENT, AND AMENDMENT THEREOF, IN ACCORDANCE WITH THE PROVISIONS OF CHAPTERS 11-2, 1967 SDCL, AND AMENDMENT THEREOF, AND REPEAL OF ALL RESOLUTIONS AND ORDINANCES IN CONFLICT THEREWITH**

**ORDINANCE 68, AN ORDINANCE AMENDING ARTICLE IV “DISTRICT REQUIREMENTS” ADOPTED BY ORDINANCE #45, AN ORDINANCE AMENDING KINGSBURY COUNTY ORDINANCE #32, AN ORDINANCE ESTABLISHING ZONING REGULATIONS FOR KINGSBURY COUNTY, SOUTH DAKOTA, AND PROVIDING FOR THE ADMINISTRATION, ENFORCEMENT, AND AMENDMENT THEREOF, IN ACCORDANCE WITH THE PROVISIONS OF CHAPTERS 11-2, 1967 SDCL, AND AMENDMENTS THEREOF, AND FOR THE REPEAL OF ALL RESOLUTIONS AND ORDINANCES IN CONFLICT THEREWITH**

The Kingsbury County Planning Commission and the Kingsbury County Board of County Commissioners will hold a joint public hearing on February 20, 2024, at 10:30 A.M. at the Kingsbury County Courthouse located at 202 2<sup>nd</sup> Street SE, DeSmet, SD. All interested persons are encouraged to attend in person and comment on Ordinances 67 & 68. After the public hearing the Planning Commission may pass a resolution recommending approval of Ordinances 67 & 68 with or without amendment, to the Board of County Commissioners. The Board of County Commissioners may have the first reading of Ordinances 67 & 68 by title and set a 2<sup>nd</sup> reading date.

The proposed Ordinances 67 & 68 will be made available for public inspection at the Kingsbury County Auditor’s Office located at 202 2<sup>nd</sup> Street SE, DeSmet, SD pursuant to SDCL Section 11-2 and amendments thereto.
