## LAKE THOMPSON CHANNEL AND OUTLET MAINTENANCE

Gass advised the Board to move into Executive Session under SDCL 1-25-2 for possible litigation for contractual matters.

Spilde moved and Walls seconded to adjourn from regular session and move into Executive Session for possible litigation at 10:03 A.M. All present voting aye, motion carried.

Spilde moved and Wolkow seconded to return to regular session. Chairman Nelson declared the Board out of Executive Session at 11:46 A.M.

Jensen moved and Spilde seconded to direct Gass to work with Knight in drafting a letter addressing the concerns raised by DENR in the maintenance of the Lake Thompson Channel and Outlet. All present voting aye, motion carried.

## RESOLUTION 2019-15

# LAKE THOMPSON CHANNEL AND OUTLET MAINTENANCE

WHEREAS, Kingsbury County, South Dakota, has met with residents on Lake Thompson in regards to the flooding that occurred throughout 2019; and

WHEREAS, the Board of County Commissioners hired Civil Design to evaluate the conditions at Lake Thompson's Channel and Outlet and Gregg Gass to represent the county at a hearing before the South Dakota Water Management Board; and

WHEREAS, the South Dakota Water Management Board approved the maintenance of the Lake Thompson Channel and Outlet subject to their continuing jurisdiction; and

WHEREAS, the Board of County Commissioners will assume no further responsibility for the Lake Thompson Channel and Outlet and will be taking this action on a one-time only basis.

NOW, THEREFOR, BE IT RESOLVED that the Board of County Commissioners for Kingsbury County will receive and pay bills up to and no more than \$10,000.00 for the maintenance project for the Lake Thompson Channel and Outlet as stated in a motion on September 24, 2019 with a roll call vote of Jensen - aye, Walls - aye, Nelson - aye, Wolkow - nay, Spilde - aye.

The underlined portion was added after the initial reading.

Walls moved and Spilde seconded to accept Resolution 2019-15 as amended. All present voting via roll call:

Jensen - aye, Walls - aye, Nelson - aye, Wolkow - nay, Spilde - aye. Motion carried.
