OFFICIAL PROCEEDINGS KINGSBURY COUNTY BOARD OF COUNTY COMMISSIONERS **Unapproved Draft Minutes**

De Smet, South Dakota November 10, 2022

The Kingsbury County Board of County Commissioners met Thursday, November 10, 2022, at 8:30 A.M. in the Courtroom of the County Courthouse with Commissioners Roger Walls, Kyle Lee, Steve Spilde, Doug Kazmerzak and Corey Lundquist present. Chairman Kazmerzak presided.

Attending via Zoom were Michelle Longville - Treasurer, Tammy Anderson - Director of Equalization, and Amy Halverson - Kingsbury Journal.

PLEDGE OF ALLEGIANCE

Those present stood and recited the Pledge of Allegiance.

APPROVE AGENDA

Echo Steffensen, Auditor, requested to move the health insurance and union discussion to executive session for contract negotiations.

Motion by Spilde and seconded by Lundquist to approve the agenda with the corrections. All present voting aye. Motion carried.

MINUTES

Motion by Lundquist and seconded by Spilde to approve the minutes of October 18, 2022. All present voting aye. Motion carried.

Motion by Lee and seconded by Spilde to approve the minutes of November 4, 2022. All present voting aye. Motion carried.

PUBLIC COMMENT

Chairman Kazmerzak asked for public comment. Steffensen thanked all the election board workers and Kingsbury County employees for their help with the election.

CONFLICT OF INTEREST

Chairman Kazmerzak asked the Board if there was any conflict of interest. There was none.

HIGHWAY

Dave Sorenson, Highway Superintendent, met with the Board to update them on highway matters.

Sorenson informed the board the 5-year County Highway Plan had been approved and presented a letter of approval from the SD Department of Transportation.

Sorenson provided an update on the shouldering project on 200^{th} street (CR 1). Approximately 7 $\frac{1}{2}$ miles have been completed and they will continue to work on it if the weather holds.

Sorenson gave an overview of the Safety Meeting he had attended in Pierre.

Sorenson presented a contract for the Lake Albert Bridge project with Leota Builders and requested said contract to be signed by Chairman Kazmerzak.

Motion by Spilde and seconded by Lee for Chairman to sign said contract. All present voting aye. Motion carried.

Sorenson presented a change order on the CR 1 project showing a decrease in the total amount of \$43,489.28 bringing the total down to \$2,799,140.28 and requested said change order to be approved and signed by Chairman Kazmerzak.

Motion by Lee and seconded by Lundquist to approve and accept the change order on the CR 1 project and for the Chairman to sign said change order.

Sorenson informed the Board that Manchester Township had completed an application for the Rural Access Infrastructure Funding and the application is on file in the Auditor office.

Sorenson stated the new truck and box that was included in the 2022 budget was in Sioux Falls. The truck will not be delivered until 2023 and Sorenson requested permission to ask for the invoice and pay it with his 2022 budget. It was the consensus of the Board to have Sorenson request the invoice and present the voucher for payment to the Auditor's office.

Commissioner Lee asked Sorenson about a transition area on CR 13 needing gravel. Sorenson said he would investigate it.

Sorenson requested to move into Executive Session for personnel.

Motion by Lee and seconded by Spilde to adjourn from regular session and move into executive session for personnel at 8:49 A.M. All present voting aye. Motion carried.

Motion by Lee and seconded by Spilde to adjourn from executive session. Chairman Kazmerzak declared the Board out at 9:06 A.M.

Sorenson requested a \$.50/hour pay increase for an employee that had completed the 6-month probationary period.

Motion by Lundquist seconded by Lee to approve a \$.50/hour pay increase for a highway employee that had completed the 6-month probationary period. All present voting aye. Motion carried.

Sorenson recommended the cameras and security system at the County highway shop be updated. He will get bids and report back to the Board.

Sorenson stated the oil burner at the highway shop needs to be replaced and is looking for a used one. The approximate cost to replace it would be \$10,000.

OPEN DISCUSSION

Chairman Kazmerzak recommended the burn ban be lifted.

Motion by Lee and seconded by Spilde to remove the burn ban effective immediately. All present voting aye. Motion carried.

MAINTENANCE

Lonny Palmlund, Maintenance, met with the Board to update them on Courthouse maintenance matters.

SHERIFF

Shelley Strande, Office manager, met with the board to update them on sheriff office matters.

The Board members congratulated Sheriff Strande on his win in the election.

The Board reviewed the vouchers submitted by the Auditor.

Motion by Walls and seconded by Lundquist that the following claims presented to the Board for consideration be approved and the County Auditor be directed to issue warrant checks for payment of same. All present voting aye. Motion carried.

Jensen provided an overview of RPP funds the County will receive from completed projects and the Riverview LLP project.

TREVOR KEATING- ARLINGTON FIRE DEPARTMENT

Keating met with the Board to inform them of the desire of the Arlington Fire Department and Arlington Ambulance to form a Fire District and an Ambulance District.
