STATES ATTORNEY

States Attorney Gregg Gass requested to move into Executive Session to discuss possible litigation.

AUDITOR

Jennifer Barnard, Auditor, reviewed the Avesis Insurance plan update with the Board. Previously only one option was available and there are three with the update. However, the county can only offer two of the plans to the group. Barnard requested a consensus or motion from the Board to offer the two plans with the majority of requests.

Spilde moved and Jensen seconded to offer the two plans with the majority of requests. All present voting via roll call: Jensen - aye, Wall - aye, Nelson - aye, Spilde - aye. Motion carried.

Barnard requested authorization to enroll in an ACH direct payment option for the new postage meter to make reloading of postage faster and easier.

Walls moved and Jensen seconded for Barnard to set up the ACH direct payment for the reloading of the postage meter. All present voting via roll call: Jensen - aye, Wall - aye, Nelson - aye, Spilde - aye. Motion carried.

OPEN DISCUSSION

Barnard requested permission to reassign \$80,000.00 from General Fund Unassigned 101-0-277 to the Emergency Management Transfers In 226-0-371 in order to bring the cash availability in good standings. Barnard clarified the Emergency Management 2019 Budget has not been overspent but that estimated revenues and State reimbursements had not come in as expected.

Jensen moved and Spilde seconded for the funds to be reassigned from the General Fund Unassigned 101-0-277 to the Emergency Management Transfers In 226-0-371. All present voting via roll call: Jensen - aye, Wall - aye, Nelson - aye, Spilde - aye. Motion carried.
