The application process is very long and there is no guarantee of approval.

Spilde moved and Wolkow seconded to adjourn from regular session and move into Executive Session for personnel at 10:34 A.M. All present voting aye, motion carried.

Jensen moved and Spilde seconded to return to regular session. Chairman Nelson declared the Board out of Executive Session at 12:00 P.M.

Board adjourned for lunch from 12:00 P.M. until 1:00 P.M.

NOW, THEREFOR, BE IT RESOLVED that \$36,900.00 be transferred from the Contingency Fund to the following funds:

TRANSFER AND ASSIGNMENT OF FUNDS

Jensen moved and Wolkow seconded to transfer \$200,000.00 from the General Fund to the Highway Road & Bridge Fund, assign \$200,000.00 to the Courthouse Repair Fund and to assign \$200,000.00 to the Capital Outlay Accumulation in the Highway Fund. All present voting aye, motion carried.

LAW CONTRACT

Barnard presented an inmate housing contract for Lake County. The fees would be \$75.00 per day for housing, \$35.00 per day for house on work release and \$30.00 per hour for transporting an inmate.

Spilde moved and Walls seconded to agree to the contract with Lake County. All present voting aye, motion carried.

HIGHWAY SUPERINTENDENT

David Sorenson, Highway Superintendent, met with the Board to discuss highway matters.

Spilde moved and Wolkow seconded to adjourn from regular session and move into Executive Session for personnel at 2:03 P.M. All present voting aye, motion carried.

Chairman Nelson declared the Board out of Executive Session at 3:32 P.M.
