OFFICIAL PROCEEDINGS KINGSBURY COUNTY BOARD OF COUNTY COMMISSIONERS

De Smet, South Dakota March 7, 2023

The Kingsbury County Board of County Commissioners met Tuesday, March 7, 2023, at 8:30 A.M. in the Courtroom of the County Courthouse with Commissioners Roger Walls, Kyle Lee, Steve Spilde, Doug Kazmerzak and Corey Lundquist present. Chairman Kazmerzak presided.

Attending via Zoom were Michelle Longville - Treasurer, Tammy Anderson - Director of Equalization, Steve Strande - Sheriff, Cindy Bau - Emergency Management, Amy Halverson - Kingsbury Journal, and Scott Erstad - Badger Oil.

PLEDGE OF ALLEGIANCE Those present stood and recited the Pledge of Allegiance.

APPROVE AGENDA

Tammy Anderson, Director of Equalization, requested to add a discussion of a vehicle purchase to the agenda.

Motion by Lundquist and seconded by Spilde to approve the agenda as edited. All present voting aye. Motion carried.

MINUTES One spelling error noted on the February 21, 2023, minutes.

Motion by Spilde and seconded by Lee to approve the minutes of February 21, 2023, with one spelling correction. All present voting aye. Motion carried.

PUBLIC COMMENT Chairman Kazmerzak asked for public comment. There was none.

CONFLICT OF INTEREST Chairman Kazmerzak asked the Board if there was any conflict of interest. There was none.

AUDITOR

Echo Steffensen, Auditor, presented the 2023 First District contracts for the Chairman to sign.

Motion by Lee and seconded by Walls to accept the 2023 First District contracts and for Chairman Kazmerzak to sign same. All present voting aye. Motion carried. Steffensen presented information on bidding for interest rates on equipment financing. HIGHWAY Dave Sorenson, Highway Superintendent, met with the Board to discuss highway matters. Matters discussed included snow removal, weight limits, purchase of a grader and delivery of the new truck. Bid opening Item #1 - Road Oil Flint Hills - MC 3000 at \$901.00 per ton. Jebro - MC 3000 at \$875.28 per ton. Sorenson recommended to accept the Jebro bid. Motion by Walls and seconded by Lundquist to accept the bid from Jebro for road oil at \$875.28 per ton. All present voting aye. Motion Carried. Item #2 - Asphalt Mix Asphalt Paving & Materials - Class E-1 \$79.00 per ton Class E2 \$81.00 per ton Bowes Construction, Inc. - Class E-1 \$76.00 per ton Class E-2 \$81.00 per ton Sorenson recommended to accept all bids to be used based on availability. Motion by Lee and seconded by Spilde to accept all bids. All present voting aye. Motion carried. Item #3 Gravel Crushing Rechnagel Construction at \$2.45 per ton of 3/4-inch. Bowes Construction, Inc. at \$2.89 per ton of 3/4-inch. 1^{st} Rate Excavation at \$3.05 per ton of 3/4-inch. Sorenson recommended to accept the bid from Rechnagel Construction.

Motion by Lee and seconded by Walls to accept the bid from Rechnagel Construction. All present voting aye. Motion carried.

Item #4 - Fuel Coles Petroleum - #2 Diesel at \$3.0775 per gallon, Unleaded Ethanol at \$2.7850 per gallon and #1 Diesel based on price of suppliers daily price plus a margin of .08.

Badger Oil - #2 Diesel at \$3.149 per gallon.

Sorenson recommended to accept the bid from Coles Petroleum.

Motion by Lundquist and seconded by Walls to accept the bid from Coles Petroleum. All present voting aye. Motion carried.

Item #5 - Quartzite L.G. Everest - Delivered \$20.60 per ton. Picked up \$12.70 per ton.

Spencer Quarries, Inc. - Picked up \$10.85 per ton.

Sorenson recommended to accept the bid from Spencer Quarries.

Motion by Walls and seconded by Lundquist to accept the bid from Spencer Quarries. All present voting aye. Motion carried.

Sorenson introduced a representative from RDO John Deere who provided information to the Board on an estimate for a new motor grader.

MAINTENANCE

Lonny Palmlund, Maintenance, met with the Board to discuss courthouse matters.

Palmlund presented a service agreement for the generator at the Sheriff's office from Interstate Power Systems for Chairman Kazmerzak's signature.

Motion by Spilde and seconded by Lee to accept the service agreement from Interstate Power Systems and for the Chairman to sign the same. All present voting aye. Motion carried.

Tammy Anderson, Director of Equalization, joined the meeting for a discussion on the cleanup of a vault which currently holds old records from her office. There are 1500 11x18 books dated from 1920-1980. Most are covered with mold. Anderson stated she is only required to keep the most recent 3 years and currently has records from 1981 to present stored on third floor. The Board discussed the history of the books and suggested

before any are destroyed the public be notified and given the opportunity to examine them.

Palmlund informed the Board he had purchased a metal box to place outside by the statues for donations to be used for upkeep and flag purchases and is working on setting up a guestbook.

Anderson met with the Board to provide them with office updates. Assessment notices have been sent. They are preparing for Equalization Boards and any appeals that may be applied for.

Motion by Spilde and seconded by Lee to allow Strande to bid on a 2017 Chevy Silverado pickup up to the approved budgeted amount in the Director of Equalization's budget. All present voting aye. Motion carried.
