#### OFFICIAL PROCEEDINGS KINGSBURY COUNTY BOARD OF COUNTY COMMISSIONERS

De Smet, South Dakota March 8, 2022

The Kingsbury County Board of County Commissioners met Tuesday, March 8, 2022, at 8:30 A.M. in the Courtroom of the County Courthouse with Commissioners Roger Walls, Kyle Lee, Steve Spilde, Doug Kazmerzak and Corey Lundquist present. Chairman Kazmerzak presided.

Attending via Zoom were Michelle Longville - Treasurer, Tammy Anderson - Director of Equalization, Steve Strande - Sheriff, Caryn Hojer - Register of Deeds, Cindy Bau - Emergency Management, Mike Siefker - Kingsbury Journal, and Angie Goebel.

#### PLEDGE OF ALLEGIANCE

Those present stood and recited the Pledge of Allegiance.

Chairman Kazmerzak acknowledged the Russia-Ukraine War and the struggles of the citizens involved.

### APPROVE AGENDA

Echo Steffensen, Auditor, requested to add a discussion of Medical Cannabis to the agenda.

Motion by Lundquist and seconded by Spilde approve the agenda as edited. All present voting aye. Motion carried.

## CONFLICT OF INTEREST

Chairman Kazmerzak asked the Board if there was any conflict of interest. There was none.

## PUBLIC COMMENT

Chairman Kazmerzak asked for public comment.

Shawn Geyer joined the meeting, and an open discussion took place on Medical Cannabis and the application/fees the county is considering.

## **HIGHWAY**

Dave Sorenson, Highway Superintendent, met with the Board to discuss highway matters.

Sorenson stated the Highway employees had completed MSHA training.

Sorenson provided the Board members with copies of the Highway Departments 2021 annual report.

Sorenson presented the agreement from the SDDOT for \$75,000.00 for the repairs to County Road 1 for Chairman Kazmerzak's signature.

Sorenson stated he had received approval on the bridge grant.

Sorenson also informed the board he had received approval on the advancement on STP funds from the state to be used for the  $200^{\rm th}$  St project. Bids for this project will be opened March  $31^{\rm st}$  and reviewed by the board at the April 5, 2022, meeting.

Sorenson recommended to accept the bid from Rechnagel Construction.

Motion by Spilde and seconded by Lee to accept the bid from Rechnagel Construction. All present voting aye. Motion carried.

Item #4 - Fuel

Coles Petroleum - #2 Diesel at \$4.498 per gallon and Unleaded Ethanol at \$4.2960 per gallon.

Motion by Walls and seconded by Lundquist to accept the bid from Coles Petroleum. All present voting aye. Motion carried.

Item #5 - Quartzite

L.G. Everest - Quartzite chips at \$21.15 per ton.

Spencer Quarries, Inc. - Quartzite chips at \$10.75 per ton.

Sorenson recommended to accept the bid from Spencer Quarries.

Motion by Lee and seconded by Spilde to accept the bid from Spencer Quarries. All present voting aye. Motion carried.

Sorenson recommended the county piggyback off the Beadle County/True North Steel bid. It was the consensus of the board to do as recommended.

Sorenson requested to meet with the Board in executive session for personnel.

Motion by Lee and seconded by Walls to adjourn from regular session and move into Executive Session for personnel at 10:02 A.M. All present voting aye. Motion carried.

Motion by Spilde and seconded by Lundquist to adjourn from Executive Session. Chairman Kazmerzak declared the Board out at 10:25 A.M.

Motion by Lee and seconded by Walls to increase the pay rate of the highway janitor to \$13.00 per hour. All present voting aye. Motion carried.

LAND LEASE AUCTION

Those present for the auction were Ron Blachford, Chad Dylla, and Austin Gehm.

Kazmerzak read the legal description of each piece of land being auctioned as follows:

Cropland in SWNE, NENE and NWNE 28-111-56 except three (3) acres located in the N 610' of the W 610' of the NE1/4 thereof (approx. 20.5 acres). The winning bid went to Gehm for \$3,900.00 annually.

NE  $\frac{1}{4}$  17-111-56 (approximately 100 acres more or less). The winning bid went to Dylla for \$5,000.00 annually.

South five acres more or less of Out Lot 3 in 32-111-56 (hay land south of highway shop on Hwy 14). The winning bid went to Gehm for \$250.00 annually.

Walls motioned and Spilde seconded to accept the winning bids. All present voting aye. Motion carried.

Motion by Lee and seconded by Spilde to adjourn from regular session and move into Planning and Zoning at 10:37 A.M. to review a Plat. All present voting aye. Motion carried.

Chairman Kazmerzak declared the Board out of Planning and Zoning at 11:00 A.M.

#### **EXTENSION**

Kathy DeDeyne - 4-H Secretary, Oakley Perry - SDSU Extension and Joan Wollschlager joined the meeting.

Commission Walls informed the Board that Mary Claire Bauer had resigned her position as 4-H Youth Advisor.

Perry addressed the Board with the options available to the county. Currently Kingsbury County and Hamlin County Co-op with a Memorandum of Understanding with SDSU Extension. The county could remain as is or leave the Co-op and/or the Memorandum of Understanding. Perry gave an overview of the benefits of both. With the Co-op each county pays 20% towards a full-time position and SDSU Extension pays the rest and offers benefits for the full-time position. SDSU also provides support for the position. Under the Memorandum of Understanding, SDSU Extension will perform the search for a candidate for the position.

Walls informed the Board of a local person who was interested in the position; however, they did not want to do both counties.

Angie Goebel - President of Leader's Assoc. addressed the Board via Zoom. Goebel expressed concerns about leaving the Co-op. By staying with the Co-op both counties can offer more opportunities for 4-H members. Also, by continuing to work with SDSU extension a larger pool of candidates could be available to chose from to fill the position.

Joan Wollschlager also spoke as a proponent to stay with Hamlin County and SDSU Extension.

It was the consensus of the Board to remain with the Co-op and provide the signed Memorandum of Understanding to SDSU Extension.

Bau informed the Board of the upcoming Severe Weather Training on March 30, 2022, at the De Smet Event Center from 6:30-8:30.

The Board adjourned at 12:04 P.M. for lunch.
