SHERIFF

Steve Strande, Sheriff, and Shelley Strande, Sheriff Office Administrative Assistant, informed the Board that Deputy Chris Jackson had graduated and was now certified. Sheriff Strande requested Deputy Jackson's salary grade be changed to Grade 30 and increase his rate of pay to \$23.70/hr.

Motion by Nelson and seconded by Spilde to approve changing Deputy Jackson's salary grade to Grade 30 and to increase his rate of pay to \$23.70/hr. All present voting aye. Motion carried.

Strande requested to move into executive session for personnel.

Remund discussed how the department heads, who are their own managers, should be handled in TimeClock. Currently all employees are required to approve their time, and their manager approves the time and requests for time off. It was the consensus of the Board that these department heads would be responsible for approving their own time.

REGISTER OF DEEDS

Caryn Hojer, Register of Deeds and IT, met with the Board to advise the Board of the need to purchase a monitor at \$250 and a printer at \$549 for the Director of Equalization and a scanner for the Veteran Services Officer.
