The Kingsbury County Board of County Commissioners met Tuesday, July 19, 2022, at 8:30 A.M. in the Courtroom of the County Courthouse with Commissioners Doug Kazmerzak, Steve Spilde, Roger Walls, Corey Lundquist and Kyle Lee present. Chairman Kazmerzak presided.

Attending via Zoom were Tammy Anderson - Director of Equalization, Michelle Longville - Treasurer, Sheriff Strande, Amy Halverson- Kingsbury Journal, and Cindy Bau- Emergency Management.

The grant funds were issued to Kingsbury County but should have been issued to the 4-H Leaders Association, therefore the County needs to issue a check to the Leaders Association.

HIGHWAY

Dave Sorenson, Highway Superintendent, updated the Board on highway matters and budget request for 2023

OPEN DISCUSSION

The Board discussed the possibility of a Road/Bridge Levy. The County could pass by resolution a levy up to \$.90/1000. The resolution would become effective 20 days after it was published if no petition was presented by Kingsbury County voters to request the levy be brought to a vote. No action was taken.

The Board discussed the gravel pit with Sorenson, Highway Superintendent.

WEED BOARD

Tanya Flegel, Weed Board updated the Board on Weed Board matters and budget request for 2023.

The Board asked Flegel if the Weed Board had decided on the pickup discussed earlier this year. Flegel stated the Weed Board agreed the pickup could be transferred to the Highway.

Motion by Lee and seconded by Spilde to transfer the 2001 Ford F350 Vin#1FDWF37D81EA33994 pickup from the Weed Board inventory to the Highway inventory. All present voting aye. Motion Carried.

TREASURER

Michelle Longville, Treasurer, met with the Board to discuss the budget request for 2023.

Longville requested to move into executive session for personnel.

Motion by Lee and seconded by Lundquist to adjourn from regular session and move into Executive Session for personnel at 10:41 A.M. All present voting aye. Motion carried.

Motion by Spilde and seconded by Lee to adjourn from Executive Session. Chairman Kazmerzak declared the Board out at 11:24 A.M.

Motion by Spilde and seconded by Lee to authorize Longville to advertise for the open Deputy Treasurer position. All present voting aye. Motion carried.

LAKE THOMPSON

Jim Knight met with the Board to discuss the water level at Lake Thompson. Knight explained the process that was taken to set the legal outlet level and informed the Board the outlet is currently dry.

Knight updated the Board on the status of forming a Water District. The petition for the Water District is ready to be forwarded to the State Water Board and Knight requested a letter of support from the Board.

PUBLIC COMMENT

Paul McMasters attended the meeting to discuss the current level of Lake Thompson. McMasters stated the actual measurement of the water level was over the legal limit and the water was still too high. McMasters requested further measurements be taken to provide proof the level is at the 1687.5 feet.

Knight agreed further measurements could be taken and he would contact East Dakota Water District to make a request. East Dakota Water District had made the previous measurements.

Tammy Anderson, Director of Equalization, met with the Board to request Executive Session for personnel.

The 3 computers would cost approximately \$4,500.00 instead of \$3,500.00. Hojer is also requesting other quotes. Hojer asked for approval to purchase 3 computers for the amount up to \$4,500.00.

Hojer informed the Board that a request had been made to investigate other software for the County offices. She has been in contact with Tyler Technologies to request a demonstration of their software.
