The Kingsbury County Board of County Commissioners met Tuesday, August 16, 2022, at 8:30 A.M. in the Courtroom of the County Courthouse with Commissioners Doug Kazmerzak, Steve Spilde, Roger Walls, Corey Lundquist and Kyle Lee present. Chairman Kazmerzak presided.

Attending via Zoom were Tammy Anderson - Director of Equalization, Michelle Longville - Treasurer, Sheriff Strande, Amy Halverson- Kingsbury Journal.

PLEDGE OF ALLEGIANCE Those present stood and recited the Pledge of Allegiance.

APPROVE AGENDA Motion by Walls and seconded by Lundquist to approve the agenda. All present voting aye. Motion carried.

MINUTES

Corrections to August 2, 2022, minutes, under Office Reports change seconded by to Steve Spilde; under Auditor Executive Session Kazmerzak declared the Board out at 12:07 P.M.

Motion by Lundquist and seconded by Lee to approve the minutes from August 2, 2022, as corrected. All present voting aye. Motion carried.

PUBLIC COMMENT Chairman Kazmerzak asked for public comment.

Kazmerzak read "Thumbs-Up" awards given by Tammy Anderson, Director of Equalization and Maggie Purintun, Deputy Director of Equalization to Dave Sorenson, Highway Superintendent, Greg Hesby, Highway Worker and Steve Strande, Sheriff.

CONFLICT OF INTEREST Chairman Kazmerzak asked the Board if there was any conflict of interest.

Kazmerzak stated he was interested in bidding on the property in the upcoming surplus property auction and would recuse himself from the proceedings.

HIGHWAY

Chairman Kazmerzak provided an update on highway matters.

AUDITOR Echo Steffensen, Auditor, requested payout of 101 hours vacation pay for Casey Harty.

Motion by Lee and seconded by Lundquist to adjourn from Executive Session. Chairman Kazmerzak declared the Board out at 9:41 A.M.

SUMMIT CARBON SOLUTIONS

Ben Fuller, Summit Carbon Solutions, met with the Board to provide an update on the proposed CO2 pipeline. The application will be submitted to the PUC October 2022 and construction to begin late summer 2023. The Board asked Fuller to address safety concerns. Fuller stated the pipeline would be monitored 24/7.

SUPPLEMENTAL BUDGET HEARING- EMERGENCY MANAGEMENT

The Board met to hold a hearing on supplementing the Emergency Management budget for 2022 in the amount of \$17,076.07 for Tango/Tango expenses paid from the Emergency Management budget. As no one appeared in opposition the following resolution was read:

Chairman Kazmerzak declared the Board out of Planning and Zoning at 10:16 A.M.

Motion by Lee and seconded by Spilde to accept and adopt Resolution 2022-17 and for Chairman Kazmerzak to sign the same. All present voting via roll call. Kazmerzak - aye, Lee - aye, Walls - aye, Lundquist - aye and Spilde - aye. Motion carried.

SHERIFF

Shelley Strande, Sheriff Office Manager, met with the board to update them on department matters.

Strande provided pictures of the roof of the Sheriff's office building showing the need for repairs.

The Board asked Strande for an update on the hiring of a new deputy. Strande informed the board that they have had some applications and would like clarification from the Board on starting salary.

The Board discussed increasing the current deputy wages by .50 per hour and setting the starting pay for a new deputy at \$41,040.00.

Motion by Lundquist and seconded by Lee to increase the current deputy and office manager wages by .50 per hour effective immediately and to set the beginning salary for a new deputy at \$41,040.00. All present voting aye. Motion carried.

Chairman Kazmerzak declared the board on recess until noon.

The Board reconvened at 12:00 P.M.

PUBLIC AUCTION

Kazmerzak recused himself and turned the meeting over to Kyle Lee, Vice Chairman.

Lee read the public notice of the property and stated the auction would be handled by bid forms. Each bidder would complete the bid form with their bid and present to the Board. After each bid the highest bid would be announced and bidders could submit another bid form with a new bid until high bid had been received.

Those present for the public auction were Doug and Carol Kazmerzak and Doug and Susan Meyer. After further discussion on the property Meyer decided not to bid. Carol Kazmerzak submitted a bid of \$10,000.00.

The Board discussed the purpose of selling the property was to get the property back on the tax rolls.

Motion by walls and seconded by Lundquist to accept the bid of \$10,000.00 from Carol Kazmerzak. Lee, Spilde, Lundquist and Walls all voting ayes. Motion carried.

Lee turned the meeting back over to Chairman Kazmerzak.

OPEN DISCUSSION

The Board held a discussion on official minutes. The Board requested Steffensen to add the cost of replacing the Sherriff's building roof to the budget and to check on the possibility of including it in the current year's budget.
