Bau read the following resolution:

KINGSBURY COUNTY DISASTER DECLARATOIN RESOLUTION

WHEREAS, Kingsbury County, South Dakota on June $30^{\rm th}$ and continuing through July $21^{\rm st}$ suffered severe storm damage caused by excessive rain and wind, and

WHEREAS, this excessive rain and wind caused county-wide flooding and wind damage, and

WHEREAS, the flooding and wind has affected all of Kingsbury County, and

Now IT BE RESOLVED THAT the Kingsbury County Commissioners do hereby declare a disaster for the population the area impacted.

The Kingsbury County Commissioners respectfully request that any and all assistance that may be available from State and Federal agencies be provided to all local governments in include Kingsbury County and to the local businesses and general population as we work to overcome this disaster.

BE IT ALSO RESOLVED THAT the Kingsbury County Commissioners do hereby declare a flood and wind disaster and respectfully request the Governor of the State of South Dakota to declare a disaster area and to request a Presidential Declaration of Disaster to insure that the maximum amount of assistance is made available to local governments, businesses and residents affected.

Jensen moved and Spilde seconded for the acceptance of the Disaster Declaration Resolution. All present voting aye, motion carried.

Bau requested authorization for Chairman Nelson to sign the State of South Dakota Department of Public Safety Office of Emergency Management 2020 Local Emergency Management Performance Grant.

Wolkow moved and Jensen seconded to authorize Chairman Nelson to sign the Performance Grant. All present voting aye, motion carried.

Bau updated the Board on the status of temporary roads for Gooseneck and Twin Lakes Roads.

Bau requested Chairman Nelson's signature to accept the State program to continue matched funding for 2020.

Spilde moved and Jensen seconded for Chairman Nelson to sign to continue receiving matched funding. All present voting aye, motion carried.

TRAVIS SICHMELLER

Travis Sichmeller, with Mettler Sichmeller Engineering, met with the Board to discuss the status of resolutions to various HVAC system issues.

Wolkow moved and Jensen seconded for a second air quality test to be performed. All present voting aye, motion carried.
