Toby Morris presented information concerning the TIF for Riverview LLP. Morris presented a preliminary discussion on the projected costs and payment terms, and calendar for the project. A request was made to be added to one of the January meetings, time and date to be determined. No action was taken.

Rhonda Siefker, Deputy Auditor presented the Board with the 2025 4-H Memorandum of Understanding Addendum with SDSU for approval and to be signed by the chairman.

Motion was made by Walls, seconded by Spilde to approve the 2025 4-H Memorandum of Understanding addendum with SDSU as presented and for the chairman to sign the same. All present voting aye. Motion carried.

Siefker requested approval of budgeted cash transfers for the Highway Fund of \$372,050.00 and \$58,729.00 from General Fund to Emergency Management Fund to cover necessary expenses.

Motion by Lundquist, second by Spilde, to approve a budgeted cash transfer of \$372,050.00 from General Fund to Highway Fund to cover necessary expenses. All present voting aye. Motion carried.

Motion by Walls, second by Nelson, to approve a budgeted cash transfer of \$58,729.00 from General Fund to Emergency Management Fund to cover necessary expenses. All present voting aye. Motion carried.

The 2025 Community Health Contract was tabled to allow the State's Attorney time for review.

### STATE'S ATTORNEY

Schumacher presented a Burn Ban Ordinance for the board's consideration and requested Rhonda Siefker, Deputy Auditor, to read the proposed ordinance.

### ORDINANCE 72

Siefker read proposed Ordinance 72 -first reading.

Ordinance 72 (Proposed)

An Ordinance Authorizing the Kingsbury County Board of Commissioners to Declare a Fire Danger Emergency and to Prohibit Open Burning Within the County

WHEREAS, pursuant to South Dakota Codified Law §7-8-20(18) the Kingsbury County Board of Commissioners authorizes the Kingsbury County Office of Emergency Management and the Chairman of the Kingsbury County Board of Commissioners to enact the Declaration of a Fire Danger Emergency and to prohibit open burning within the County or restrict open burning, after consultation with local fire officials and law enforcement officials, in order to protect public health and safety; and

BE IT ORDAINED BY KINGSBURY COUNTY, that if a "Fire Danger Emergency" be declared, all open burning of any substance shall be prohibited within any or all of the unincorporated area of Kingsbury County until such time as the resolution declaring the "Fire Danger Emergency" shall have been rescinded by appropriate action of the Kingsbury County Board Commissioners; and

BE IT FURTHERORDAINED BY KINGSBURY COUNTY, that any person who shall create, commit, maintain, or permit to be created, committed or maintained an open burning in violation of a resolution declaring a "Fire Danger Emergency" shall be deemed to have committed a public nuisance in violation and subject to all criminal and civil penalties provided for therein. Any person who maintains, commits, or fails to abate a public nuisance as required under the provisions of this ordinance shall be subject to a maximum penalty of thirty (30) days in jail, a Five Hundred Dollar (\$500.00) fine, or both. Each day that the violation continues may constitute a separate offense.

### Section 1. Definitions:

- A. Open Burning: Any outdoor fire, including but not limited to the prescribed burning of fence rows, fields, wildlands, trash, and debris, the intentional burning of any substance whether natural or manmade, or the intentional casting off of any burning substance, whether natural or manmade, except the burning of such substance in a container sufficient so as to prohibit the escape of any of the burning substance, or escape of any sparks, flames, or hot ashes from the container. This also excludes fires that are contained within liquid-fueled or gas-fueled stoves, fireplaces within all buildings, charcoal grill fires at private residences, and permanent fire pits or fire grates located on supervised developed picnic grounds and campgrounds.
- B. Open Fire: Any outdoor fire, including a campfire, that is not contained within a fully enclosed fire box or structure from which the products of combustion are emitted directed to the open atmosphere without passing through a stack, duct, or chimney with spark arresters. Open fire shall not include charcoal grilles, liquid fuel grills, outdoor fireplaces, or burn barrels, as defined herein.
- C. Charcoal Grill: A metal or stone device not resting on the ground with a metal grate designed to cook food using charcoal briquettes, char wood, hard wood, or similar fuel.
- D. Liquid Fuel Grill: A metal or stone device designed to cook food using liquefied or gaseous combustible fuel.

- E. Burn Barrel: A metal container used to hold combustible or flammable waste materials so that they can be ignited for the purpose of disposal. Burn barrels must have a metal grate; metal grate opening shall be no larger than a quarter square inch (1/4") covering at any time when in use. Burn barrels must be located in a safety zone, away from any or all combustible materials, of a fifteen-foot (15') radius of the burn barrel.
- F. Outdoor Fireplace: A manufactured appliance constructed of non-combustible materials, with a maximum duel area of three feet (3'), including a screen (screen opening shall be no larger than a quarter square inch (1/4'')), chimney or other device placed above the fuel area, fueled by cut or split wood, located not closer than fifteen feet (15') to any combustible surface and continually attended.
- G. Campground: Any permitted commercial campground operated by private individuals or corporations, State of South Dakota, Kingsbury County, or the United State National Park Service.

The second reading of Ordinance 72 will be read on December 17,2024.

Schumacher, State's Attorney, presented the Jail Contract Agreement with Lake County on behalf of Sheriff Strande. There were no changes noted from the 2024 contract.

Motion by Lundquist, seconded by Nelson to approve the contract and for the chairman to sign said contract. All present voting aye. Motion carried.

#### EXECUTIVE SESSION

Motion by Lundquist and seconded by Nelson to adjourn from regular session and move into executive session for legal matters at 11:35 AM. All present voting aye. Motion carried.
