This strategic move was undertaken to minimize Association banking fees and offer you, our Co-owners, more mays to eliminate the dues processing fees that many of you are currently paying with Zego and Bank of America.

Given this change, and in order to inform you of the various options you have going forward to make your monthly dues payment, please select one of the methods of payment below.

## No-cost payment options

1. Checks prepared by you and mailed directly to the bank. <u>Please include your payment coupon</u> and address envelopes to:

Account Numbers can also be found on your payment coupons.

2. Checks prepared by you and mailed directly to Property Services Group, our Management Company. Address payments to:

Please remember to include your payment coupon. <u>Please be aware that payments sent to</u> <u>Property Services Group will result in processing delays for up to 7-10 business days.</u>

3. Use Bill Pay if it is available at your bank or credit union. Most banks and credit unions now offer this service free of charge and allows you to send 1-time payments <u>or</u> recurring payments directly to the payee. Most banks and credit unions will even allow you to automatically stop the payments after a certain number of recurring payments. Most banks will also notify you by email or text when the payment is being sent if you request.

If using Bill Pay as your payment method, use the Phoenix, Arizona address described in #1 above. You will be required to enter your account number (located on your payment coupon and described in 1 above). If asked for a Biller phone number, it is <u>(866) 800-4656</u>. You will also likely have a comments section where you can just put "Monthly dues, (your street address), Crossings at Irving Avenue".

4. Use ACH payment process. ACH payments are similar to the automatic pay method you may already be using for car, cell phones and utility payments. If interested in this free service, complete the Preauthorized Electronic Assessment Payment Service Agreement and Disclosure Statement attached to this email and send it to:
