The data consists of received allegations of sexual abuse and/or harassment, investigative outcomes, and sexual assault incident reviews.

The data from 2023 and 2024 is compiled from Transitional Living Centers male and female centers (TLC and Bethesda) that are contracted with the Pennsylvania Department of Corrections.

The data reflects allegations and incidents specific to the following categories:

- Reentrant on Reentrant non-consenual acts
- Reentrant on Reentrant sexual abuse
- Reentrant on reentrant sexual harassment
- Staff on reentrant sexual abuse
- Staff on reentrant sexual harassment

Analysis and Conclusions:

- There were zero allegations of abuse or harassment of employee on reentrant. This is an improvement from 2023 as there was 1 allegation of employee on reentrant sexual abuse.
- In 2024 there was 1 allegation of reentrant on reentrant sexual abuse that was unsubstantiated. In 2023, there was one allegation of reentrant on reentrant sexual abuse that was founded. The allegation in 2024 is from TLC while the allegation from 2023 was Bethesda House. Bethesda house has decreased allegations of sexual abuse.
- There has been 1 allegation of reentrant on reentrant sexual harassment and the investigation is ongoing. In 2023, there was also one allegation.
- Bethesda House Bethesda has decreased overall allegations in 2024.
- TLC TLC has maintained 1 allegation for 2023 and 2024.

Transitional Living Centers, Inc. continues to work to create a safe environment and prevent, detect, and respond to sexual abuse and harassment.
