Introduction:

The Prison Rape Elimination Act of 2003 was enacted by the federal government to prevent, detect, and respond to incidents of sexual abuse and harassment within confinement settings. Transitional Living Centers, Inc. Annual Report is covering calendar year for 2024.

The data consists of received allegations of sexual abuse and/or harassment, investigative outcomes, and sexual assault incident reviews.

The data from 2023, 2024, and 2025 is compiled from Transitional Living Centers male and female centers (TLC and Bethesda) that are contracted with the Pennsylvania Department of Corrections.

The data reflects allegations and incidents specific to the following categories:

- Reentrant on Reentrant non-consensual acts
- Reentrant on Reentrant sexual abuse
- Reentrant on reentrant sexual harassment
- Staff on reentrant sexual abuse
- Staff on reentrant sexual harassment

Analysis and Conclusions:

- There were zero allegations of abuse or harassment of employee on reentrant at TLC. Bethesda House had 1 allegation of abuse of an employee on reentrant. That allegation was unfounded.
- There were zero allegations of abuse or harassment of reentrant on reentrant at TLC. That is an improvement from 2024 as there was one allegation made that was unsubstantiated. There was 1 allegation of harassment at Bethesda House that is pending investigation.
- In 2025 Bethesda House increased in allegations. In 2024 there was 1 and 2025 there have been 2.
- In 2025 TLC has reduced allegations. They had 1 allegation in 2024 and 0 in 2025.

Transitional Living Centers, Inc. continues to work to create a safe environment and prevent, detect, and respond to sexual abuse and harassment.
