**Resolution #672 – SEPTEMBER/OCTOBER 2025****Erlendson - Senkowski**

Be it resolved that Westlake Watershed District accept the quote from Hiller Electric of \$4,617.28 inc PST of \$288.58 and GST of \$206.13, to trench power to the Westlake Watershed District shed, and install a panel, interior lights and interior and exterior plugs. Funds for this project are to come from Tier 1.
