Sub-District 157(L) – Happy projects are getting done **Sub-District 107(A)** –

- Jack Cruze is contact for Ducks Unlimited decommission.
- MAW has applied to be administer the PWCP program again, Saskatchewan has decided to look after their own PWCP program from now on.

Sub-District 107(L) -

- Hamlin Dr culverts need to be replaced. Would like to get them assessed and ordered at the end of the season. The manager indicated that the seasonal general laborers inspected them and there is a list of the culverts that need to be replaced.
- Is there a list of culverts in the RM of Lakeshore compound? and if so, for what project? Suggested spray painting the district culverts so it is clear to see which ones belong to the District. Manager indicated that there is an inventory list available.
- Need to be sure to stick to quotes for tendered projects.

Sub-District 110 -

- Provincial Engineer, Ken R. is working on culvert sizes on Garrioch culverts, still waiting for recommendations.
- Would like to get brushing done on Rd 130 and 278
- Sandy Bay meeting went well.
- Need concrete pads for the Jack Pine and Preston park garbage bins.
- Wondering how long Debbie will be working with the district?
- Compound base is completed. Thank you, David & Tim, for helping out with this project, your help is appreciated.

Sub-District 160 -

- South Leifer (CertainTeed) Mine is working on re-opening and will be mining gypsum
 and the flooded pits will be pump into 3-tiered pits that are pumped overland into a
 district drain. Board would like to have cut off dates for pumping due to our culverts
 freezing up. Manager and board member will be setting up a site meeting with Jim
 Nailer to take a look at the site and follow up with conditions to water rights licensing.
- Also thought the Sandy Bay meeting went well. Presented their Watershed Plan. Was
 interested in their app that they will be using. Will check it out for more information.
 Ken Dunn added that the meeting shared some good information. Passed card onto
 manager in case we need surveying done.
- Would like to get North Leifer brushing done
- Culverts on Harcus need to be replaced.
- DU meeting is going to be taking place sometime in December. Will be discussing decommissioning.
- Beaver dam removal high pressure system should be looked at.

Sub-District 113 – Lonely Lake crossing needs culverts ordered. Would like to look at putting original design back with the 5 pipes. Manager will contact the Provincial Engineer Ken R to see if he has any recommendations for this crossing.

Provincial Rep. – Would like to thank Ken Dunn for all his help with compound and in general, all the district work he is helping with.
