Sub-district 157(L) – There is a beaver blockage on north of 364. Would like the district drone to be flown to look at the extent of beaver dams in that area.

Sub-district 107(L) – Spence Lake committee is having a difficult time to schedule meeting. Have not been able to come to an agreement on a meeting date.

• Horyn Dr west beaver dam, would like the drone to also fly down this drain to see the extent of the beaver dams in this area.

Sub-distict 110 – Would like to look at who the recommendations come from for crossings. Manager mentioned the recommendations come from water rights license branch.

- Wondering how Birdina data is going, need to hold a landowner meeting sooner then later.
 Would like to fix or replace culvert that has come apart on Birdina road and received temporary fix, after the harvest is done.
- Would like to contact Reedy Creek Construction to complete brushing project along highway 278 that was unable to get done last year due to signage requirements.
- Would like to place the garbage bins at Preston park before the end of the year. The board discussed and suggested to go with 24 by 30 patio blocks for the foundation under bins rather than pouring cement. Will try to arrange to get this done before General Labourer is done.
