WLWD board decided to send another letter to Minister Moyes, Minister Kostyshyn and Minister Simard seeking clarification on OIC status, and if Weiden drain does not have this status, the board is seeking assistance to obtain it or receive assistance in obtaining permission to resume maintenance and reconstruction activities as soon as possible according to existing MB Natural Resources Plan and Profile for Weiden Drain. RM of Lakeshore and

Mossey River Municipality will be invited to also submit their letters of concern with Westlake WD, so that they are delivered to the Ministers as a package.
