ARTICLES OF INCORPORATION

BE IT KNOWN, that on this 19th day of August, 1996, before me, the undersigned Notary Public in and for the Parish and State aforesaid, personally came and appeared the undersigned, being a person of full age of majority whose signature is subscribed who declares, in the presence of the undersigned competent witnesses the Availing himself of the provisions of the Louisiana Nonprofit Corporation law, Louisiana Post 12, 269 Listen A (1950 as amended), he does hereby organize a nonprofit corpe accordance with these articles of incorporation as follows:

ARTICLE I

The name of this corporation is HIGHLAND OAKS TO ASSOCIATION, INC.

ARTICLE II

2.1 The Association is a non-profit corporation and does not contemplate pecuniary gain or profit, direct or indirect, to its members.

2.2 The purposes for which this Association is formed are to provide for maintenance, preservation and architectural control of the townhouse property of Highland Oaks Townhouse Community, particularly the common elements thereof, and to promote the health, safety and welfare of the owners and residents of said townhouse property, situated in the Parish of East Baton Rouge, State of Louisiana (hereinafter called the "Properties"). Its further purpose shall be to acquire, hold, encumber, convey, manage, regulate and maintain the townhouse property, particularly the common elements and common surplus thereof; to fix assessments, charges and penalties to be levied against the members; to enforce any and all provisions of the Declaration of Covenants and Restrictions of Highland Oaks, Second Filing, A Townhouse Community (hereinafter called the "Townhouse Declaration") and other agreements applicable to the Properties; and to do any other things as may be permitted by law, that will promote the common benefit and enjoyment of the owners and residence of the Properties. The activities of the corporation shall be conducted for the aforesaid purposes in such a manner that no part of its net earnings will inure to the benefit of any member, director, officer or individual. It shall not be its purpose to engage in carrying on propaganda or otherwise attempting to influence legislation. The powers of the corporation shall be as such as are reasonably necessary to the accomplishment of these purposes and shall include all powers, rights, privileges and immunities to the fullest extent permitted under the laws.

ARTICLE III

This corporation shall exist in perpetuity.

ARTICLE IV

This corporation shall be organized without capital stock. Every person or entity who is or may become a record owner of any condominium unit which is subject to the Townhouse Declaration shall be a member of this corporation. There shall be only one class of members and members shall be entitled to one (1) vote per each condominium unit (as defined in the Townhouse Declaration) which is owned.

ARTICLE V

The affairs of the corporation shall be directed by a Board of Directors composed of at least one but not more than four Directors who need not be members of the corporation. The initial Board of Directors shall hold office until the election of their successors at the first annual membership meeting. The Directors elected thereat and thereafter shall serve for such terms as specified in the Bylaws of this corporation or until their successors are elected. Additions to properties and membership may be made only in accordance with the provisions of the Townhouse Declaration.

ARTICLE VII

The annual meeting of the voting members of the corporation shall be held on the first Monday of the month of August, or in the event that date is a legal holiday, on the first Monday thereafter which is not a legal holiday.
