

☆ ABORTION IS PROHIBITED IN JUDAISM



Abortion is prohibited in Judaism, just as murdering innocents is prohibited. The Talmud (Sanhedrin 57b) says that a fetus is included in the Noahide prohibition of bloodshed (distinct from homicide) that is learned from Genesis 9:6 that states (in a direct translation from the Hebrew),

“He who spills the blood of man within man shall have his blood spilt.”

The Talmud interprets "the blood of man in man" as to include a fetus, which is the blood of man in man. Things that are prohibited under the Noahide laws are also prohibited to Jews. The penalty of having his blood spilt, is interpreted by Maimonides as referring to a punishment by the hands of heaven, and not by the courts or man to man.

"Whoever destroys a soul, it is considered as if he destroyed an entire world."
Mishnah Sanhedrin 4:9; Babylonian Talmud, Sanhedrin 37a

This is the basis of the biblical argument against abortion.

☆ EXCEPTION TO THE PROHIBITION

Judaism was the original source of the specific “to save the life of the Mother” exception.

The Mishnah explicitly indicates that one must abort a fetus if the continuation of pregnancy might imperil the physical life of the woman.

*If a woman is in hard travail, one cuts up the offspring in her womb and brings it forth member by member, because her life comes before the life of her foetus. But if the greater part has proceeded forth, one may not set aside one person for the sake of saving another.**

This exception to the prohibition of abortion was intended to be used only in the case of imminent death of the Mother because of breech birth, when the baby would act as a danger ‘rodef’ to the Mother



All pro-life legislation includes a “life of the mother exception” for life threatening purposes.

☆ THE MEDICAL EXCEPTION TODAY

Currently, only 1% of pregnancies present a life threatening situation for the Mother. Former United States Surgeon General, Dr. C. Everett Koop, stated publicly that in his thirty-eight years as a pediatric surgeon, he was never aware of a single situation in which a freeborn child's life had to be taken in order to save the life of the mother.*

Ectopic pregnancy is primarily the only valid exception today. Ectopic pregnancy refers to any pregnancy that is implanted outside the uterus, most commonly in the fallopian tube. By the time an ectopic pregnancy has been discovered (usually by 7 to 8 weeks gestation) the embryo has died in the majority of cases. However, the supporting tissues for the pregnancy often continue to grow and can cause life-threatening bleeding, either through rupture of the fallopian tube or other mechanisms.**




Exceptions to the prohibition against abortion in Judaism have expanded until now abortion is accepted as birth control by many Jews and Jewish leaders. Since the destruction of the temples and subsequent dispersions and exile, Jewish abortion opinions have been influenced by secular cultures, and Torah has been misused to justify unlimited abortion practices.

✧ MISUSE OF TORAH LANGUAGE

And should men quarrel and hit a pregnant woman, and she miscarries but there is no fatality, he shall surely be punished, when the woman's husband makes demands of him, and he shall give [restitution] according to the judges' [orders]. But if there is a fatality, you shall give a life for a life. Exodus 21: 22-23.

Long used by abortion advocates to reframe abortion as legal in Judaism, this text is not a license to abort an unborn child, rather, it is a reference to involuntary manslaughter, which is not a capital crime.

It shall come to pass: if the woman had been defiled . . . her belly will swell and her thigh will rupture. Numbers 5:27



This refers to the case of a sotah, the hiding wife. The medical event described is mistakenly thought to be an abortion; however, traditional Jewish interpretation of this test for impurity doesn't mention pregnancy as a result of adultery, nor does it mention abortion as a result of drinking the potion. Rather, the bitter water actually kills the woman outright.* Talmudic opinion on the sotah dilemma states that if adultery has occurred, the bitter water kills both adulterers when the woman drinks.**

The Sotah is not a woman who is known to have actually committed adultery, but rather one whose behavior makes her suspect of having done so. Her faithfulness to her husband must therefore be established before the marriage relationship can be resumed. Before drinking the potion, the woman is warned that if she has indeed committed adultery, the bitter waters will kill her; if, however, she has not actually been unfaithful, the drinking of these waters exonerates her completely. In fact, the Torah promises that, having subjected herself to the ordeal, her marriage will now be even more rewarding and fruitful than before her going astray.

☆ WHAT DOES HASHEM SAY?

Noahide Law - Do not murder.

Genesis 9: 6-7: Whoso sheddeth man's blood within man shall his blood be shed: for in the image of God made He man. And you, be fruitful, and multiply; swarm in the earth, and multiply therein.

Exodus 20:13: Thou shalt not murder.

Leviticus 18:21: And thou shalt not give any of thy seed or set them apart to Molech, neither shalt thou profane the name of thy God: I am the Lord.

Deuteronomy 30:19: I call heaven and earth to witness against you this day, that I have set before thee life and death, the blessing and the curse; therefore, choose life, that thou mayest live, thou and thy seed.







There are three stages in a man's life: (a) in the womb, (b) in this world and (c) in the world to come. When the child is in the mother's womb all his needs are met. If it were up to him, he would remain there forever. When he leaves the womb it is because he has no choice in the matter. In truth, whatever takes place in the womb is wondrous and beyond our comprehension, such as how the infant exists in that environment, and what it is that forces him, at the appropriate time, to emerge from there. Just as the understanding of the workings of this phenomenon is hidden from us, so too the work of G-d, in general, is hidden from our comprehension and is wondrous. The fact that we cannot comprehend it should not prevent us, however, from appreciating and seeing the hand of G-d and the wonders of His creation, every day, as we go about our daily lives.




The Unborn Child is “considered to be mere water” until its 40 Day. FALSE



☆ WHAT DOES THE AMA SAY?

The American Medical Association (AMA) declared as far back as 1857 (referenced in the Roe. vs. Wade opinion) that:

The independent and actual existence of the child before birth, as a living being is a matter of objective science.

The AMA deplored the medieval opinion that reflected popular ignorance...that the fetus is not alive until after the period of quickening.

3. Level of Development
4. Level of Dependency *


Changing the meaning of words doesn't change reality.

Like toddler and adolescent, the terms embryo and fetus do not refer to nonhumans, but to humans at particular stages of development.



Dr. Bernard Nathanson, internationally known obstetrician and gynecologist, was a cofounder of what is now the National Abortion Rights Action League (NARAL). He owned and operated what was at the time the largest abortion clinic in the western hemisphere. He was directly involved in over sixty thousand abortions.

Dr. Nathanson's study of developments in the science of fetology and his use of ultrasound to observe the unborn child in the womb led him to the conclusion that he had made a horrible mistake. Resigning from his lucrative position, Nathanson wrote in the New England Journal of Medicine that he was deeply troubled by his *"increasing certainty that I had in fact presided over 60,000 deaths."*



In his film, "The Silent Scream" Nathanson later stated, **"Modern technologies have convinced us that beyond question the unborn child is simply another human being, another member of the human community, indistinguishable in every way from any of us."** Dr. Nathanson wrote Aborting America to inform the public of the realities behind the abortion rights movement of which he had been a primary leader. At the time Dr. Nathanson was an atheist. His conclusions were not even remotely religious, but squarely based on the biological facts.

Dr. Nathanson later sought a Jewish faith leader for spiritual help. No rabbi would/could help him. He died a converted Catholic.





✡ WHAT DO RABBIS SAY?

Thus, the discovery of DNA and when it first emerges in a human being should change our thinking about the beginning of human life in the same way that the discovery that babies born in the eight month of pregnancy are viable (ben qayyama) changed our thinking about early infant life, even though in the days of the Talmud people believed that they were not viable.



Jews are bound by halakhic norms. With regard to questions of human life and death, however, they are not bound to some of their applications that are based on what we now know to have been inaccurate, outdated science. The science of the Talmud has been superseded by more current science, which itself might be superseded in the future.

☆ VIABILITY IS NOW AT 22 WEEKS GESTATION

Count the children of Levi according to their fathers' house according to their families.
Count all males from the age of one month and upward. Numbers 3:15

The census methodology counted only male babies one month of age and older because that milestone was considered the age of viability at that time. It is not a statement of non-personhood for unborn children, children under the age of one month, or for females; it is merely a pragmatic method of counting.

This text should not be used as a Torah based argument for killing unborn children or killing children under one month of age, just as it cannot be used as justification for killing females at any age!

Viability is now an astonishing 22 weeks. With neonatal care, babies live outside the womb. Many thrive and go on to live normal healthy lives. One such miracle of life is shown below.



The little girl was born at 21 weeks 4 days. At three weeks old in 2014, Courtney Stensrud's daughter is pictured here with Stensrud's and her husband's wedding rings on her arm. As of November 2017, she is a healthy 3 year old child.



☆ THE MORAL IMPERATIVE

We now know without a doubt that abortion kills an innocent living human being. Judaism prohibits killing an innocent person. Therefore, in Judaism abortion is wrong.

Rabbi Simcha Wasserman

1990 - 1993.

Born in Imperial Russia and educated in France, the young Wasserman founded the first of his four rabbinical seminaries at Strasbourg in 1933. All four are in operation.

He came to the United States before World War II on the orders of his father, a renowned Talmud scholar and leader of the Agudath Israel movement who was executed by German forces in 1941. Active in New York-based Vaad Hatzolo , a committee that tried to save European Jews during the war, Wasserman returned to Europe with a U.N. relief team to help with the resettlement of refugees.

After founding a seminary in Detroit, he arrived in Los Angeles in 1953, where he opened a yeshiva that offered elementary, secondary, college and post-graduate training in traditional Jewish texts as well as secular studies to local youths and others who came from as far as Arizona and Colorado.


One of the first Orthodox rabbis to reach out to the rapidly assimilating Jewish community in Los Angeles, Wasserman was credited by students and colleagues with training a generation of rabbis and lay leaders and laying the groundwork for a resurgence of traditional observance in recent years.

"He represented a carry-over from an era that has vanished of the Old World scholar who really symbolized the heights of rabbinic scholarship that we only read about in our legends and in tales of centuries past," said yeshiva alumnus David Fox, a clinical psychologist and rabbi.

They also remembered him as an exceptionally warm and humble mentor.



"A Jew is governed by such reverence for life that he trembles lest he tamper unmindfully with the greatest of all divine gifts, the bestowal or withholding of which is the prerogative of God alone. 



Sometimes we must protest for sacred and noble causes. It bleeds my heart that none of the Jewish organizations – even none of the orthodox organizations – in New York protested the recently passed abortion law under almost all circumstances as long as the woman and her doctor agree. The Rabbis in New York know that this law will lead to all forms of immorality. And they know that according to the Rambam abortion is akin to murder. Yet they are afraid to get involved, afraid to speak up. In this connection we must say: אשמנו מכל דור. It is precisely because New York has a concentration of Jews that New York was the state to pass the new abortion law, and the Jewish members of the New York legislature supported the law. In fact, the legislature at first defeated the abortion bill; but one New York state senator, a Jew, who had at first voted against the bill reported that on Pesach night while sitting at the Seder he had a pang of conscience and thought that by his vote against the abortion bill he might cause difficulty and suffering to some girl who would otherwise have solved her problem by obtaining an abortion. Then he switched his vote and the bill was passed. Why did not any of the Rabbis in New York reassure him that his first thoughts had been right? We must say here: אשמנו מכל דור.

“I consider the society of today as insane...I read from the press that in Eretz Yisrael they permit abortions now! Sapir comes to the US and asks that 60,000 boys and girls should leave the US and settle in Eretz Yisrael. When a child is born, it's also immigration to Eretz Yisrael, and yet you murder the children.”

“And if you kill the fetus, a time will come when even infants will be killed...The mother will get frightened after the baby will be born...and the doctor will say her life depends upon the murder of the baby. And you have a word, mental hygiene, whatever you want you can subsume under mental hygiene...And there is now a tendency for rabbis in the US to march along with society, otherwise they'll be looked upon as reactionaries.”





☆ THE ABORTION INDUSTRY

Abortion providers have long been exempt from standard medical practices and regulatory oversight, and decades of illegal and unethical practices are finally being uncovered. Planned Parenthood Federation of America (PPFA) is the primary provider of abortions in the U.S. According to PPFA's most recent 2016-2017 annual report, it committed 321,384 abortions in fiscal year 2016. According to these numbers, Planned Parenthood aborted 881 babies every single day in fiscal year 2016.

While Planned Parenthood holds non-profit status, its total revenue for 2016-2017 was about \$1.459 billion, the highest in its history. In 2016-2017, PPFA reported an excess of revenue over expenses of \$98.5 million, an increase of \$21 million in a year alone.

In 2016-2017, Planned Parenthood received \$543.7 million in combined federal, state and local government grants and contracts, a decrease of almost \$11 million from last year's funding. Of all funding received by Planned Parenthood, 37% comes from taxpayers' pockets.

Several of the websites Adagio recommends for teens include sites that link to Planned Parenthood abortion facilities, and one encourages teens to chat online with Planned Parenthood about their sex-related questions.

Many parents become very upset when they learn Planned Parenthood teaches their students about sex. School districts in North Carolina and Michigan recently rejected Planned Parenthood sex education programs because of a strong public outcry.


According to a CBS report, the North Carolina parents said Planned Parenthood's "Get Real" curriculum "encourages sixth graders to feel 'comfortable and ready' for sex. The petition says the curriculum provides flash cards outlining proper condom usage, for 'vaginal, oral or anal sex' and recommends the usage of 'non-microwavable saran wrap' as a prophylactic for certain non-reproductive sex acts."

In 2017, another Pennsylvania school district also rejected a plan to put a Planned Parenthood-run facility inside Reading High School after massive public protests. Planned Parenthood is the largest abortion provider in the United States, aborting more than 300,000 unborn babies every year. The abortion chain also teaches sex education in public schools across the country, and promotes risky sexual behavior to vulnerable young teens at its clinics.

In 2014, Live Action release an undercover video series showing Planned Parenthood employees encouraging young teens to participate in sado-masochistic sexual activities, including gagging, whipping, asphyxiation, shopping at sex stores and viewing pornography.

Planned Parenthood's booklet for HIV-positive youth, "Healthy, Happy and Hot," tells young people that it is their "human right" to not tell their partner that they have HIV. The abortion giant also publishes multiple "resources" for children and teenagers concerning sexual activity. These materials claim to provide "age appropriate" sex education to children starting at age 4.







☆ ABORTION HURTS MEN

When a Jewish man coerces his partner into abortion, he may feel relief immediately afterward from the social, financial, or religious consequences of claiming fatherhood. Later, though, feelings of anger, resentment, and guilt often surface. These uncomfortable feelings come out in destructive behaviors - excessive drinking, drug use, suicidal feelings, risk taking or maybe running from relationship to relationship unable to make commitments.

☆ A LACK OF JEWISH HELP

Judaism emphasizes the sanctity of human life from conception to natural death, making it incumbent upon Jews to find ways to save lives when dealing with unplanned and unwanted pregnancy. Adoption, marriage, and single parenthood are much better choices for Jews than the intentional killing of an innocent life to avoid embarrassment, inconvenience, or hardship. When pregnancy results from a mistake in judgement or action, killing innocent life is not the answer.

- ☆ Childbirth is much safer for women than abortion.
- ☆ Choosing life avoids perpetuating the anti-semitic origins of the abortion industry.
- ☆ Choosing life for our unborn children saves them from a violent, painful death by abortion and allows them to live with a loving family, one of our making or an adoptive one.



The JPLF is often contacted by Jewish couples wanting to adopt a Jewish baby. We have a waiting list.

The quality of a society [and the hallmark of Judaism] is largely defined by how it treats its weakest and most vulnerable members. Killing the innocent is never justified because it relieves others of a burden. It is not a solution to inflict suffering on one person in order that another may avoid it. What defined Nazi Germany as an evil society was its wanton disregard for human life. That disregard surfaced in Hitler's killing of 275,000 handicapped people before he began killing the Jews.*

Nat discovered reports of experiments in what doctors at Yale-New Haven Hospital called "early death as a management option" for infants "considered to have little or no hope of achieving meaningful 'humanhood.'" Nat then interviewed happy handicapped adults whose parents could have killed them but didn't. This changed him.**

☆ GLAD TO BE HERE

The eugenics movement popularized and implemented in Germany first targeted the physically and mentally disabled. Killing these people in order to improve the gene pool found legitimacy in the courts and in public opinion. Once this activity was approved, the legalized killing of Jews followed suit.*

Condoning abortions of babies with genetic defects starts us down that path again. Determining that any innocent human person should die is outside of Jewish moral teachings. Considering that Jews have historically been categorized as subhuman and exterminated, Jewish justification for aborting due to imperfection defies common sense.


For physical and mental disabilities for which many believe the child's & family's best interest is served by abortion, a good question to ask is, “ if your healthy child becomes disabled, is it acceptable to kill that child because it is a burden to the family? No, we hope not. The child in the womb deserves the same consideration.

✧ CIRCUMSTANCES OF CONCEPTION

Unfortunate circumstances of conception need not determine who lives or dies. While the reputation of the mother and family may be damaged because of a pregnancy due to rape or incest, a healthy child in a healthy mother is not a direct threat to the mother's physical life.

According to the Mishneh Torah, a mamzer, a person conceived through incest or rape, is not allowed to marry a Jew or have a Jewish lifestyle. The death penalty is not the punishment for this unfortunate circumstance of birth.*

Well meaning Jewish authorities who recommend abortion in these cases fail to recognize that the abortion kills an innocent unborn child, and that abortion is a dangerous procedure that hurts women physically, mentally and emotionally far more than carrying a child to term. The emotional health of the mother and the reputation of the family can be better served through the life saving option of adoption rather than termination, allowing the child to live a productive life and the parents to live without the guilt after abortion.

This exception is accepted basically among Jews everywhere, unfortunately it is very ingrained in the Orthodox community, which is why we don't affiliate with any Jewish denomination.

Research shows that women who abort a pregnancy conceived in sexual assault reported that abortion had been the wrong solution. Most women who had abortions say that abortion only increased the trauma they were experiencing. In many cases, the victim faced strong pressure or demands to abort. In almost all the cases where the victim became pregnant through incest, abortion was chosen by the perpetrator to cover up the incest and the victim rarely, if ever, had a say in the matter. None of the women who gave birth to a child conceived in sexual assault expressed regret or wished they had aborted instead.*


