To Rabbis for Repro:

⚡ Publicly championing abortion rights as a religious right jeopardizes Jewish posterity because it persuades good Jews to believe the lie that abortion is normative in Judaism. This lie has led to the intentional killing of hundreds of thousands of innocent Jewish lives - an estimated 2 million in Israel since 1948 and 845,856 in the US since 1973.

⚡ Abortion is prohibited in Judaism, with one rare exception allowed only when the mother's physical life is imminently threatened. This occurs in less than 1% of pregnancies. Jeremiah 7:30 clearly shows that the Lord God opposes child sacrifice: *"For the Children of Judah have done that which is evil in My sight, saith the Lord; they have set their detestable things in the house whereon My name is called, to defile it. And they have built the high places of Topheth, which is the valley of the son of Hinnom, to burn their sons and daughters in the fire which I commanded not, neither came it into my mind."*

⚡ Abortion is not a civil right. It is not healthcare. It is not a choice. It is the ultimate form of child abuse. Judaism demands a high level of compassion and mercy for the vulnerable and defenseless. No other demographic is as vulnerable as the defenseless child in the womb.

⚡ Publicly promoting abortion rights as a religious right misrepresents Judaism as a heartless baby killing cult. It suggests that Jews lack compassion for unborn babies who are given no pain medication before being starved, poisoned, burned, dismembered, and whose skull is punctured and crushed after partial delivery or who are delivered perfect and alive for organ harvesting. As early as 10 weeks, an unborn baby feels real physical pain during an abortion. As Jews we cannot inflict this torture on innocents. Jeremiah 22:3 clearly explains: *This is what Adonai says: "Do what is right and just; rescue the wronged from their oppressors; do nothing wrong or violent to the stranger, orphan or widow; don't shed innocent blood in this place."*

⚡ Publicly promoting abortion rights as a religious right endangers the safety and security of all Jews because it perpetuates the blood libel myth that Judaism sanctions the killing of Christian children. This charge is the basis upon which many Jews have been imprisoned, tortured, and killed.

⚡ 1.2 million Jewish children were 'legally' killed by the Nazis. Telling people that abortion is a religious right helps the abortion industry and their political allies legislate legal murder of children before and after birth.

⚡ Abortion poses great danger to mothers, fathers, families, and communities. Women suffer horribly after abortion with devastating physical, emotional, psychological, and spiritual problems. Abortion as birth control encourages irresponsible, dangerous sexual activity leading to an explosion of sexually transmitted disease. Women die from legal abortion. Men grieve lost fatherhood.

✧ Nazi scientists developed RU-486, now used in 40% of all abortions due to inflated pricing and low overhead costs. Originally called Zyklon B, it was used in gaseous form to kill Jews in concentration camp 'showers.' Never again becomes once again each time a Jewish child dies from RU-486.

✧ Everything about the abortion industry goes against everything Jewish, as described in Exodus 23:7: *"Keep away from fraud, and do not cause the death of the innocent and righteous; for I will not justify the wicked."* Abortion providers have long been exempt from standard medical practices and regulatory oversight. They perpetuate sex crimes by routinely failing to report evidence of sexual assault and sex trafficking. They fail to provide informed consent to patients and fail to counsel patients on alternatives to the abortion procedure or possible immediate and long-term negative consequences of the procedure.

✧ The Illegal sale of body parts and the extreme violation of basic moral standards regarding dismemberment of born alive babies runs contrary to Jewish ethics. Judaism prohibits desecrating the human body, but abortion destroys a human body, and the harvesting of baby parts for profit defies Jewish respect for the dead.

✧ The Religious Coalition for Reproductive Choice and the National Council of Jewish Women deliberately employ propaganda successfully utilized by Adolf Hitler to reconstruct compassion and concern for women into lethal tools that facilitate elimination of Jews, people of color, and not so perfect people. "We must use every means to install in the population the idea that it is harmful to have several children, the expenses that they cause and the dangerous effect on woman's health... It will be necessary to open special institutions for abortions, and doctors must be able to help out there in case there is any question of this being a breach of their professional ethics." (Adolf Hitler 1942)

✧ Judaism allows Teshuvah for almost any sin against God and man. Our tradition offers leniency to Jews who break covenant with HaShem due to ignorance and manipulation. The Jewish Pro-Life Foundation supports transformation from deceived perpetrator of the blood libel and the abortion holocaust to righteous, spiritually mature life advocate who reflects the lovingkindness and Providential reality referred to in Jeremiah 29:11: *"For I know the plans I have for you," declares the LORD, "plans to prosper you and not to harm you, plans to give you hope and a future."*
