ATTACHMENT TO

ARTICLES OF INCORPORATION FOR A NONPROFIT CORPORATION

CLUB RESIDENCES OWNERS ASSOCIATION

Pursuant to § 7-122-102, of the Colorado Revised Statutes, the following additional provisions are hereby incorporated into the foregoing Articles of Incorporation for Club Residences Owners Association, a Colorado nonprofit corporation (the "Association"). In the event the foregoing and this attachment conflict, this attachment shall control:

- 10. <u>Limitation of Liability</u>: No director of the Association shall have any liability to the Association or to its members for monetary damages for breach of fiduciary duty as a director or be personally liable for any injury to person or property arising out of a tort committed by and employee, except to the extent such exemption from liability is not permitted under the Colorado Revised Nonprofit Corporation Act. Any repeal or modification of the foregoing sentence shall not adversely affect any right or protection of a director in respect of any act or omission occurring prior to such repeal or modification.
- 11. <u>Dissolution</u>: The Association may be dissolved in the manner permitted by the Colorado Revised Nonprofit Corporation Act and with the assent given in writing and signed by members representing not less than sixty-seven percent (67%) of the aggregate number of votes as described in the Declaration for Club Residences recorded or to be recorded in the office of the Clerk and Recorder of Eagle County, Colorado, as amended from time to time (the "Declaration"). Upon dissolution of the Association, the assets, both real and personal, of the Association shall be distributed pursuant to the Declaration and the Colorado Common Interest Ownership Act (CCIOA), as set forth in Article 33.3, Title 38, Colorado Revised Statutes, as such Act exists on the date hereof, except to the extent that the applicability of future amendments to the Act are mandatory.
