The meeting was opened for public comment on the budget and there being no public in attendance the public hearing on the budget was closed. Mr. Marchetti reviewed the financial statements through September and the 2023 budget numbers. Mr. Marchetti asked the timing on bonds and Mr. Cohen said it's on hold pending the outcome of the sale of the area in the Districts and waiting for presales to happen first as well. The County is planning to discuss the Districts in the next meeting, for the housing authority. There was a discussion about the debt issuance and whether it should be budgeted in 2023. Mr. Greher stated that a Debt service Mill Levy could be done but that a decision needs to be made before December 15th. Mr. Marchetti suggested putting the discussion off until the next regular board meeting, board members agreed and the 2023 budget hearing was continued to the next meeting.
