2023 Budget Resolutions and Mill Levies

Conversion of Developer Advances Into Debt Obligation

Offers on the sales of property in the Districts were too low per Mr. Cohen, so the sale will not be going through, but sales to individual homeowners will start in the near future. Mr. Cohen asked what goes into the conversion of developer advances to debt and Mr. Greher described the Note or Bond process. That process can best be done after sales of units have commenced.
