heirs, executors, administrators and assigns, hereby release and forever discharge PRO KARTZ, LLC. agents and employees and assigns of and from any and every claim, demand, action, of whatever kind of nature, either in law or in equity, arising from or by reason of any bodily injury or personal injuries, known or unknown, death or property damage resulting, or to result from any accident which may occur and any activities in the operation of the equipment whether by negligence or otherwise.

RULES AND SAFETY INFORMATION:

Operator hereby agrees to the following:

- 1. Operator will obey all local, state and federal regulations regarding the operation of this equipment on public traffic ways, parking lots, and in public access areas.
- 2. Operator understands that PRO KARTZ, LLC is not responsible for speeding tickets, parking tickets, or any other traffic citation incurred during the rental period.
