ADDENDA #1 - ISSUED 2/2/2023

- 1. In the Bid Advertisement, all dates listed as "2022" are corrected to "2023". The advertisements were republished with the corrected dates.
- 2. Item #11 was posted on our glidefire.org website on 1/19/23. This is the **Asbestos Survey** performed 3/30/2022.

3. Submit bids on the attached revised Bid Form.

- 4. This addendum clarifies that **ALL materials used in this project shall be to the building's original construction specifications** dated 2013, unless modified by building codes since 2013. Portions of these specifications applicable to this project are posted on our website.
 - a) This includes but is not limited to the **flooring products** acceptable for use on this project, as listed on the **specification page for Resilient Flooring 09650-2**. If specified materials are no longer available, materials of equal or higher quality and suitable for commercial use must be approved by the Owner.

The complete 2013 construction specifications are available for review at the fire station, and any portion applicable to this rehabilitation project can be requested to be posted on our website.

- 5. The **2013 Flooring Schedule A1.2** is attached for reference. As noted in the Scope of Work for this Rehabilitation project, no flooring will be installed in the Physical Training Room #128, the EMS Room #133, and the PPE Room #110. Please note that, contrary to the 2013 Flooring Schedule A1.2, LVT flooring is to be installed in Room #119 (which was originally bare concrete).
- 6. The contractor may supply and place a Conex (or similar) **storage container** in the parking area outside the SE corner of the station, for storage of Glide Fire's cabinetry, doors, and appliances currently stored in the Training Room and Kitchen, along with contractor's tools, materials, and supplies.
- 7. During construction, the station will be open for construction activity Monday through Friday 7am to 6pm. Any other days and/or hours will require owner preauthorization.
- 8. The Office areas will continue to be used by personnel during construction. The contractor will install a floor-to-ceiling plastic barrier in the Office Workroom #105 to protect office work areas. Glide Fire personnel will access the office area from the front lobby. Because Glide Fire personnel will need 24-hour access to the Apparatus Bay area, contractors' construction equipment, materials, and supplies will not be stored in the Apparatus Bay.

- 9. Base Bid shall include repair of concrete slab cracks in EMS Supply Room #133, PPE Room #110, and Report Writing Room #119 only. Base bid EXCLUDES any other repair of the existing concrete slab imperfections. Base bid excludes the filling of valleys and cracks, the grinding of peaks, or the installation of a self-leveling underlayment to the existing concrete surface in any rooms except rooms #133, #110, and #119.
- 10. The Add-on Pricing listed below shall be provided. The contractor will perform all necessary work to level the concrete slab surface to meet the flooring manufacturers' minimum standards. This work may include grinding of the concrete slab surface in some areas, in addition to the placement of commercial-quality self-leveling cementitious underlayment with a compressive strength of at least 4,400 psi in 28 days, a tensile bond strength of at least 1,150 psi in 7 days, and as further specified below.
 - a) Provide Add-on Price #2 to repair concrete slab cracks, clean and prepare concrete slab surface, apply primer to concrete slab surface, and install a commercial-quality self-leveling cementitious underlayment to the existing concrete slab surface in the Training Room #103 and the Day Room #117 only. The surface preparation and self-leveling underlayment will be placed according to the manufacturer's product specifications. Self-leveling product will be feather edged to prevent a tripping hazard where the self-leveling product overlaps slab areas not being resurfaced. If any door clearances are affected by the change in floor height, wooden doors shall be trimmed without splintering the door panels.
 - b) Provide Add-on Price #3 to repair concrete slab cracks, clean and prepare concrete slab surface, apply primer to concrete slab surface, and install a commercial-quality self-leveling cementitious underlayment to the existing concrete slab surface in all Hallways (Rooms #114, #118, #121, #127), Report Writing Room #119, and the Kitchen Room #116. The surface preparation and self-leveling underlayment will be placed according to the manufacturer's product specifications. Self-leveling product will be feather edged to prevent a tripping hazard where the self-leveling product overlaps slab areas not being resurfaced. If any door clearances are affected by the change in floor height, wooden doors shall be trimmed without splintering the door panels.
 - c) Provide Add-on Price #4 to repair concrete slab cracks, clean and prepare concrete slab surface, apply primer to concrete slab surface, and install a commercial-quality self-leveling cementitious underlayment to the existing concrete slab surface in the Physical Training Room #128 and in all other rooms in which Vinyl or LVT flooring will be installed; this is for rooms not included in Add-on Price #2 or Add-on Price #3. The surface preparation and self-leveling underlayment will be placed according to the manufacturer's product specifications. Self-leveling product will be feather edged to prevent a tripping hazard where the self-leveling product overlaps slab areas not being resurfaced. If any door clearances are affected by the change in floor height, wooden doors shall be trimmed without splintering the door panels.
