\*Tax deposits (without interest) totaled \$6,892.76 for month of February 2025. Of this, \$5,351.68 was for the General Fund, and \$1,541.08 was for the Debt Service Fund.

Total expenses for the month of February were \$65,810.35, including:

- \$33,198.88 paid from the General Fund, including:
  - \$3,831.00 for Special Districts Health Insurance
  - \$3,450.00 for Neuner, Davidson & CO Final Audit Billing
  - o Payroll/Liability Expenses
- \$10,390.70 paid from the Building Construction Fund
  - \$9,995.70 for the new Camera System of which \$5,000 was from the SDAO
    Grant from 2022 for Safety/Security upgrades
- \$22,220.77 paid from the Wildfire Readiness Fund, for CWRR grant expenses
  - o \$22,200.00 Trees/Bush + Us
