Legal Status in Oregon

Oregon laws ORS 677.761 - Persons and practices not within scope of ORS 677.757 to 677.770

As recognized in Oregon law, Reiki and similar “alternative” or “complementary” healing practices are **not regulated under the state’s medical licensing statutes.**

Providing Reiki, energy healing, intuitive readings, or spiritual coaching in Oregon does **not require a state-issued medical license** - provided the practitioner does not misrepresent themselves as a licensed medical provider or offer medical diagnoses or treatments.

According, I practice under this exemption; my services are offered as non-regulated wellness and spiritual support, and I make no claims that they are “medical treatments,” “therapies,” “cures,” or “diagnoses.”

By scheduling and participating in a session, you acknowledge that you:


1. Understand the nature and limitations of the services
