## Resolution No. 2021-5

## A RESOLUTION OF THE CITY OF COZAD, DAWSON COUNTY, NEBRASKA, AUTHORIZING THE TEMPORARY USE OF THE STATE HIGHWAY SYSTEM WITHIN THE OFFICIAL CORPORATE LIMITS OF THE CITY AND ACCEPTING DUTIES SET OUT PURSUANT TO NEBRASKA REVISED STATUTES 39-1359.

**SECTION 1.** On July 9, 2021 at 5:00 p.m. until July 12, 2021 the City of Cozad, will be temporarily using the State Highway System by closing a small portion thereof for an annual Community festivity known as Bands, Brews, BBQs. The portion of the State Highway System being utilized lies completely within the corporate limits of the City of Cozad and pursuant to Neb. Rev. Stat. 39-1359, the City assumes the duty of protecting the highway property from damages that may occur arising of said practice activity. The proposed closed portion is more particularly described as the 200 Block of East 8<sup>th</sup> Street and "F" Street from 8<sup>th</sup> Street to Highway 30. Traffic will be re-routed on the 300 Block of East 8<sup>th</sup> and South on "D" Street from 8<sup>th</sup> Street to Highway 30.

**SECTION 2.** The City of Cozad formally acknowledges that it accepts all the duties established by Nebraska Revised Statutes, 39-1359 and will indemnify, defend, and hold harmless the State from all claims, demands, actions, damages and liabilities, including reasonable attorney's fees that may arise as a result of this practice activity.

SECTION 3. The Mayor and City Clerk of the City of Cozad are hereby authorized to execute all documents necessary

to effectuate the actions contemplated by this Resolution.
