Open Meeting:

Mayor Eagleson called the meeting to order at 7:00 pm followed by the Pledge of Allegiance.

Council members answered to roll call: Jeff Smith, Trace DeGarmo, Rocky Henson, Shawn Coombs, and Dustin Monen.

Approve/amend Agenda:

DeGarmo moved to approve agenda as amended. Coombs seconded. All in favor. Motion carried.

CenturyWest:

Remmick reported the council needs to make a decision on engineering services that was advertised for two weeks in the Davenport Times. The City received three proposals and decided to continue with Century West for engineering services. Coombs made a motion to accept Century West as the City engineer. Monen seconded. All in favor. Motion carried.

Remmick reported that the lift station improvement project is almost finished, just waiting on some paperwork issues before we can close out.

<u>Flood Damage Repairs:</u> Remmick has been meeting with the Army Corps of Engineers and will be meeting with Fish and Wildlife in about a week to go over some things about the bridge. Coombs asked if the bridge will be done in a year. Remmick stated he hopes to get it completed this year. Remmick explained that FEMA is only paying for 75% of it and the City will have to come up with the rest. There are Remmick said there are CDBG grants available for that. Applications are due in June and we won't know if the City is accepted until September, and if so, the money will come in November. CDBG will not fund retroactively so we do not want to get too far ahead on projects if the City will not get reimbursed.

<u>L & I Hearing:</u> See attached letter from Stanley Schwartz regarding the meeting Mayor Eagleson, Councilmember Coombs, and Kyle Canaday attended on March 19. The City attorney Stanley Schwartz sent Corey Mitchum from Labor and Industries a settlement proposal that states the City will appropriate the monetary amount of the fine over a four-year period to provide safety training classes and equipment. Coombs made a motion for Mayor Eagleson to sign the agreement if they accept once it comes in to the City. Monen seconded. All in favor. Motion carried.

Behrens requested that Lisa Hendrickson be added as a signatory to the checking account. Smith made a motion to add Hendrickson as a signatory. Coombs seconded. All in favor. Motion carried.
