Now to get down to brass tacks—do you want the "Bulletin" to carry on?



#### MINUTES OF THE BOARD OF DIRECTORS MEETING OF THE SOUND BEACH PROPERTY OWNERS' ASSOCIATION, INC.

The meeting was held at Kneer's Hof Brau, 3210 Broadway, Astoria, L. I. on Thursday, October 1st, 1942. Meeting was called to order by Chairman, Dr. Brennan at 9:00 P.M., with the following representation:

GUESTS: Mrs. Pfistner, Mr. Kress, Mrs. Claus, Mr. Arthur Hafner, Mrs. Brennan, Mrs. Wink, Mr. Thomas Cerrio.

Motion made, seconded and carried that the minutes of the previous meeting be accepted as published in the Bulletin.

Dr. Brennan stated that in response to the item which we ran in the two previous issues of our Bulletin, asking the membership whether or not they desired the Bulletin to be continued, or what their pleasure was in the matter, that we had received one response from Mr. A. Shire. This letter was read to the body present.

Dr. Brennan also read a letter which he had received from Mr. Cnattingius stating his inability to attend this meeting.

Mr. Hafner stated that there was some painting to be done on the West Ramp on the new promenade deck. He stated that he had received an estimate for doing this work, but the Board felt that he should receive others before giving out the work. He stated that he would try to secure some more and report back to the Board regarding the same.

Dr. Brennan stated that he had the water from the pump at the Community House and at the West Ramp analyzed by the Suffolk County Health Department to be sure that the water was safe for drinking purposes. He stated that a satisfactory report was received. He stated that the pump at the West Ramp was in need of repairs and that the water pumped from same was pumping clay, silt or rust making it unsatisfactory to use as drinking water. He stated that in view of the large number of people using this pump, that it might be a good idea, when we are having it put in good condition, to find out the cost of electrifying it. Motion was made, seconded and carried that the President be authorized to see the pump man regarding the necessary repairs to this pump and also find out the cost of putting a motor on same and report back to the Board at its next meeting.

Motion made, seconded and carried that the Secretary be directed to write a letter to the Concessionaire at the Club House requesting that he let us know his plans for the coming winter for the care of the Club House.

The question of a sluiceway at the gully between Brookhaven and Amangansett Drive was brought up again and the chairman stated that he had written to Mr. Still, Highway Supervisor of the Town of Brookhaven asking him to investigate the situation and give us his advice as to what would be the best way of handling the existing condition. Up to the time of the meeting, no reply had been received.

Mr. Cnattingius suggested that we turn over to the local scrap committee the fire rings scattered around Sound Beach. Several tons of metal of the finest type for war purposes can be obtained from these rings. There was a question of ownership of these rings which will be investigated if possible before the general meeting so action may be taken.

There being no further business to transact, motion made, seconded and carried that the meeting be adjourned at 11:45 P.M. Respectfully submitted,





Dr. Brennan stated he had a meeting in Sound Beach with Mr. Still and they both looked over what he would do in case it should be decided to have this done. Dr. Brennan stated that the reason this was under-discussion now was that the Board could


We have been warning the members in previous issues of the bulletins that their lack of interest and selfishness will some day result in a condition which apparently has come to pass.
