
## MAINE/NEW HAMPSHIRE/VERMONT DISTRICT CAREER CONFERENCE

**Did you know** In New Hampshire, postmasters can request a special **vanity license plate** that features the **five-digit ZIP code** of their Post Office. Here's how it works:

- The plate is issued to **one vehicle** of a current postmaster.
- If a city has multiple ZIP codes, the postmaster can assign the remaining codes to postal carriers.
- These plates must be surrendered when the postmaster (or postal carrier) leaves their position or when the vehicle registration expires.

It's a neat way to represent your role and your community—like a badge of honor on wheels.

#### UMPA NATIONAL NEWS

PMA National President Tony Leonardi highlights our legislative concerns in UPMA Today while urging UPMA members nationwide to call their U.S. Senators right away to help ensure that pending legislation does not adversely affect our members' earned retirement benefits.

Tony Leonardi, National President of the United Postmasters and Managers of America (UPMA), has indeed been vocal about protecting members' retirement benefits. In a recent UPMA Today video, he urged members across the country to contact their U.S. Senators immediately regarding pending legislation that could negatively impact earned retirement benefits.

Leonardi's message underscores the importance of grassroots advocacy, especially when legislative changes threaten the financial security of postal managers and postmasters. His call to action reflects UPMA's ongoing commitment to safeguarding the rights and benefits of its members.

The legislation raising concern among UPMA members is the **Concurrent Resolution on the Budget for Fiscal Year 2025**. According to UPMA President Tony Leonardi, this proposal includes several provisions that could significantly impact postal employees' retirement security:

- **Increased retirement contributions** for current employees, effectively reducing take-home pay.
- A shift from the current "high-3" to a "high-5" salary calculation for pension benefits, which would lower overall retirement payouts.
- Elimination of the FERS early retirement supplement, which supports employees who retire before age 62.

Leonardi emphasized that these changes would not only penalize long-serving postal workers—many of whom are veterans—but also make it harder to recruit and retain talent, especially in rural areas.

The House has already passed a reconciliation bill (H.R. 1) by a narrow margin that includes some of these cuts. That's why UPMA is urging members to contact their Senators immediately to oppose these provisions.

I am writing as a constituent and proud member of the United Postmasters and Managers of America (UPMA) to express my deep concern regarding provisions in the FY2025 Budget Resolution that threaten the earned retirement benefits of dedicated federal employees.


These proposals would significantly reduce retirement security for postal employees by:

- Increasing retirement contribution requirements, reducing take-home pay
- Changing pension calculations from "high-3" to "high-5" salary averages
- Eliminating the FERS annuity supplement for those retiring before age 62

These changes would amount to an unfair reduction in compensation—particularly for those who have devoted decades of service to our country. Many affected are veterans and rural public servants who have upheld the integrity and operation of our postal system. I urge you to reject any provision that unfairly targets federal employee benefits and to support legislation that values the commitment and contributions of postal workers.


