talks with the NRLCA. He too continually went back to addressing and having a successful peak this year.

We had several persons from HQ that facilitated training on Rural Delivery, Hiring Process. Also the new pilot program USPS Local Connect which is being tested in Texas and is part of the 10 year plan, Delivering for America. There was also training for our own Health and well being such as– how to detox from sugar, Alzheimer's information, retirement information, and more.

When Disaster Strikes

The Postal Employees' Relief Fund (PERF)

PERF exists to help active and retired postal employees, both management and craft, whose home, as a result of a major natural disaster was completely destroyed or left uninhabitable--displacing the postal employee and their family for an extended period of time. The Fund provides small relief grants to assist qualifying victims of such circumstances re-establish residence and to help replenish basic necessities in the aftermath of a devastating loss. If you have been a victim of a major disaster such as a hurricane, tornado, flood, wildfire, or earthquake, and meet the criteria described above, we urge you to print and complete the APPLICATION FORM on this website and mail it, along with required documentation, to PERF. The Grantors of the Fund are the Postmaster General and the Presidents of the National Association of Letter Carriers, American Postal Workers Union, National Postal Mail Handlers Union, National Rural Letter Carriers Association, National Association of Postal Supervisors, and the President of the United Postmasters and Managers of America.

Each of the Grantors selects an individual to represent their organization on the Fund's Executive Committee, which handles the day-to-day operations of the Fund. PERF is a 501(c)(3) charitable organization operated by the various management and union organizations of the U.S. Postal Service to benefit postal employees. The Fund was created in 1990 to assist postal employees affected by Hurricane Hugo and the California earthquake, and to provide a permanent process to assist postal employees who become victims of a major natural disaster. The Fund has provided thousands of grants totaling millions of dollars to active and retired postal employees impacted by hurricanes, typhoons, earthquakes, floods, tornadoes, wildfires and isolated house fires.

Don't blame the messenger, instead try to develop a working relationship with Local Services so we can make the best of a bad situation. All that said, the hiring "buck" stops with us.

Since leaving Hudson several years ago I have not had the pleasure of needing to fill a future career position, so I personally won't be much help. If your encountering hurdles with the on boarding process call a neighboring Postmaster, maybe in a larger office that deals with this on a weekly basis, I'm sure they can provide guidance. Don't ever let it get you to the point that you have to explain to your manager why you went off on an HR person. Dignity and respect must always be the most important part of our exchanges with co-workers, no matter who they are or where they work.



Legislative Report



In my last article I questioned whether this would be the year meaningful Postal Reform makes it to a vote in the Senate and House of Representatives. Now that the summer is over it will be interesting to see where Congress places their efforts. The bill that has the most support is the Postal Service Reform Act of 2021 (HR 3076). The legislation will include elimination of the current pre-funding mandate of USPS healthcare cost, requires new postal retirees to enroll in Medicare (but optional for current retirees), requires preservation of six-day delivery, provides flexibility to the PMG to utilize ground transportation for cost efficiency and flexibility, and requires key progress reports to Congress on the PMG's implementation of his reform plan. The latter point, requiring reports to Congress is a UPMA priority and one that we were successful in getting included in the Collins (R-ME)/ Feinstein (D-CA) because it is important to a number of members of Congress to support this legislation. Most of the stakeholders are in support of this legislation and there is broad bipartisan support from both sides of the aisle. This is a key point as in these contentious political times, to have bipartisan support for any bill, never mind a Postal reform bill is more than unusual, it is almost unheard of. This fact alone is what is driving the opti-

mism for this bill coming to a vote. Of course, Congress is easily distracted on other matters, but the optimism remains. Several members of NH UPMA will be attending the Legislative Conference at the end of this month. We hope to able to meet some or all our four NH legislators off site from their offices as Federal buildings are closed to the public. Barring those type of meetings, we do have plans to ZOOM with either them or their aides. Hopefully our efforts, along with all the other UPMA members in other states meeting with their representatives will provide the momentum we need to get this important legislation passed.

Keep your fingers crossed and contact your local representative and let them know we need their support on this bill!

Another National Convention has come and gone and we are moving ahead into an unknown future of the USPS. We heard from our Postmaster General Louis Dejoy who has a vision of a successful future of the Postal Service. He repeatedly said that our changes are not

without growing pains and will take some time to transform our business model into a successful one. Mr. Dejoy took many questions from the Chapter members who asked many times about moving forward with staffing, vehicles and infrastructure. Mr. Dejoy says that he has started the restructuring and while this is still going on it will streamline our reporting structure and decrease redundancies in the system.

He also said that he is appreciative of the dedication of the EAS employees and the great job they have done over the past 18 months of Covid 19. He says he understands the problems with the current PFP program and it needs to be fixed. He reiterated several times that his current focus is peak and settling the dust of the restructuring. He said we need to rebuild our confidence with our customers during peak this year moving forward. He was asked about Post Plan 2 which rumors have been around about level 18's. While he stated this is not his current focus he did not dispel the rumors that it is in the works. This leads me to believe if you are in a level 18 with no delivery there is a good possibility that your office may be included in a second round of Post Plan initiatives.

My advice to you is start looking for a new landing spot. Most likely they will follow similar guidelines for placements but as you already know the process moves quickly and with the latest restructuring open positions may not be as readily available as they are currently.

We also heard from Deputy Postmaster General / Chief Human Resources Officer Doug Tulino. He also took many questions from the members. Most of the questions were in regards to staffing and PFP. Mr. Tulino said many times he agrees that the pay for performance system needs to be looked at. It is definitely not a perfect system. As far as staffing goes, he listened to at least a dozen Postmasters complain about the "Fast Track" hiring system that is also broken.

Some Postmasters has complained it has taken nearly a year to onboard new employes and others complained that it is not doing a good job of lining up qualified candidates resulting in retention issues and then the process starts He also said that right now his focus is getting people on for PEAK.

As with all Conventions we had time to have some fun and

also learn from each other. We took a dinner cruise on Lake Erie and watched a beautiful sunset. We also spent a day in Put-in-Bay island which was a terrific place to relax, shop and enjoy a pint or two with great sunshine and music and talk about best



practices at work and in life. While I have to say the Kalahari was not the best venue. I don't think anyone was really intersted in a "water park" and the programs and the hotel schedules felt a bit disjointed, the Convention itself was well managed and had allot to offer both seasoned and new Postmasters and Managers in attendance. The training was some of the best I have seen, with some headquarters staffing on site leading some of the trainings. There were also a large group of vendors who specialize in Postal Retirement. Ready and waiting to assist anyone who may be approaching retirement days.
