

Legislative Report

Legislative News!

Now that Postal reform has been passed, what is next on the legislative agenda? The Fair Treatment of Civil Service Retirement System (CSRS) Annuitants—WEP/GPO; H.R. 82 is still on our agenda. Congress enacted two provisions more than three decades ago that unfairly penalized CSRS annuitants: the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO). The WEP is a one-size-fits-all mechanism that reduces workers' Social Security benefits who participate in pension plans from employment not covered by Social Security, such as the CSRS. The GPO reduces a CSRS retiree's Social Security spousal or survivor benefits by an amount equal to about two-thirds of the CSRS annuity. All three bills would significantly impact the retirement security of retired Postal Service employees and current employees covered by the CSRS. Numerous testimonials of retired federal employees adversely affected by this unfair provision have been presented to Congressional leaders to no avail. We are currently at the 290 co-sponsors that would fast track the bill for a vote. The number of cosponsors has remained about the same for years now but has recently seen an influx and

there does seem to be energy behind getting a vote to the floor. The biggest obstacle to the bill has always been the costs. Arguments have been made that the money has already been paid to the treasury, or that the costs would only be an extremely small percentage of social security. These kinds of discussions just muddy the water and make it harder to generate support. But as we saw with the Postal reform bill, perseverance does pay off. I do not believe that any of our congressman or Senators from NH have signed onto this bill yet. An e-mail or phone call from a retiree affected by this provision and a

testimonial on the results could be enough to get them to sign on.


The NH Executive Board voted to pay \$25 to any UPMA sponsor who signs up a new EAS member to UPMA. With no limit of how many

(this does not mean using your personal vehicle). If you do not have the means and your POOM is upset Please keep us in the loop. Document your attempts to get help from other offices and let your POOM know your current situation and your plans to make it up the next day. Please do not wait until you are called for a meeting with your POOM due to circumstances out of your control to contact one of us. Remember we are tasked with delivering all the mail everyday.

Once you have been a member for one year and start to pay your dues if you get into any trouble with your boss, POOM or Inspectors and are given corrective action you will have representation to work with you. If it can not be settled then UPMA has the Adverse Action team which is a team of Federal Lawyers that will work on your appeal to the Merit Systems Protection Board. You never know what can happen in the Postal Service or when your going to need some in your corner. Noone is immune. Please understand it's not all work and no fun. Being involved this past year with UPMA I got the chance to meet new friends, go to Washington DC for Legislative Summit, Fall Luncheon, State Convention, Saint Louis MO national convention and in September (2 weeks away) we have the North East Conference and then the Fall Luncheon. 


