# **SUMMARY**

The Feed Mill Operator is responsible for executing all processes within the bagging department to manufacture products. Assists in product scheduling and workflow management to ensure successful operations.

#### **ESSENTIAL DUTIES AND RESPONSIBILITIES:**

- Bags complete feeds
- Sealing and labeling of products
- Adheres to company safety practices.
- · Conducts grading of ingredients received.
- Listens to bagging equipment and identifies mechanical needs that may need attention.
- Performs the daily housekeeping of bagging area and department.
- Ensures daily, weekly, and monthly routine preventative maintenance tasks.
- Work with employees to identify and address ingredient flow or equipment issues.
- Provide effective communication with customers and co-workers.
- Provide excellent customer service and positively contribute to an environment of teamwork.
- Demonstrates attention to detail and ability to problem solve.
- Know, maintain, adhere to, and promote all safety standards and governmental regulations.
- Lift and move bagged products.
- Perform other duties as assigned by the supervisor.
