**DECLARATION OF AMY HAROLD
SMALL, RESIDUAL BENEFICIARY**

I, Amy Jane Small, declare as follows:

1. I am a Residual Beneficiary of the Sharon M. Harold Irrevocable Trust dated November 12, 2004 ("Trust"). I have personal knowledge of the facts set forth herein. I make this declaration in support of the Joint Objection to Verified Petition for Approval of Interim Account; For Discharge of Successor Trustee; and For Appointment of Successor Trustee ("Objection").

2. At all relevant times herein, the documents attached hereto were obtained by me either under power of attorney or express permission granted by Sharon Harold, my mother and Grantor.

3. Trustee David Paice ("David" or "Trustee") is my nephew by marriage to my niece Briana Paice. Trustee's attorney mailed a packet to me on August 9, 2022

1 which contained Trustee's Accounting of Trust.

2 4. As part of my review of my mother's accounting records, I discovered a
3 check dated March 29, 2010 for \$2,000. When I attempted to reconcile this check with
4 Trustee's accounting, I discovered that Trustee listed this check on Schedule J as
5 being written for \$8,000. A true and correct copy of this check and the related
6 Schedule J is attached hereto as Exhibit 1.

7 5. I found in my mother's records a series of checks from the BECU trust
8 account written between April 2010 and April 2020. I noticed that some of these
9 checks were issued to Grantor for monthly disbursements and/or expenses. These
10 checks were all signed by Trustee. I also noticed that there were no endorsement
11 signatures on the backs, but "for deposit only" had been written by someone other
12 than Grantor. The handwriting, printing and capitalization varied on these checks, and
13 the scanned images were cut off so information was missing. True and correct copies
14 of these checks are collectively attached hereto as Exhibit 2.

15 6. I located a signature card for my mother's USAA checking and savings
16 accounts signed by Trustee and her, which granted Trustee power of attorney for her
17 two USAA accounts. A true and correct copy of which is attached hereto as Exhibit 3.

18 7. I found a check dated April 24, 2014 from Trustee drawn from Northern
19 Trust, and not the trust account, in payment of my mother's monthly disbursement. In
20 the corresponding BECU trust account statement, this transaction was characterized
21 as an "External Withdrawal SHARON HAROLD-ONLINE PMT". However, on Trustee's
22 Schedule J, it was categorized as a wire transfer. A true and correct copy of the check,
23 statement and Schedule J is collectively attached hereto as Exhibit 4.

24 8. On November 2, 2021, I found another monthly disbursement check
25 from Trustee for Grantor from a Wells Fargo account, not the trust account. This time
26 this check listed Trustee's name and his personal home address. When I tried to
27 reconcile this payment on Trustee's Schedule J, I discovered that this transaction was
28 not listed. A true and correct copy of the Wells Fargo check and the corresponding

1 Schedule J is collectively attached hereto as Exhibit 5.

2 9. My mother received a letter from LPL Financial dated January 20, 2023,
3 entitled "Duplicate Confirmation/Trade confirmation for 1/12/23" and states that a sell
4 order was placed against the fidelity advisor Strategic CLA account in the amount of
5 \$17,000. I have never seen a notification like this in my mother's records before. A
6 true and correct copy of this letter is attached hereto as Exhibit 6.

7 10. While reviewing my mother's records, I came across a letter she wrote to
8 David Llewellyn requesting information regarding her accounts because she could not
9 get the information from Trustee. A true and correct copy of that letter is attached
10 hereto as Exhibit 7.

11 11. On April 27, 2022, at my mother's request, I sent a letter to Trustee
12 requesting a full accounting with supporting documents. A true and correct copy of
13 this letter is attached hereto as Exhibit 8.

14 12. My mother had Trustee removed from her USAA checking and savings
15 accounts in October, 2022. USAA is confirming this removal by letter, which I have
16 not received as yet.

17 13. On November 1, 2021, Trustee called Amy on the phone. During that
18 phone conversation, he told me that he had concerns about my mother's mental
19 health, and that he no longer wished to continue as trustee. He also stated that there
20 was not enough money for moving my mother to a health care facility.

21 14. On March 6, 2022, my brother texted me and informed me that my
22 mother had fallen and suffered a severe head injury requiring hospitalization. A true
23 and correct copy of the pictures sent to me is attached hereto as Exhibit 10.

24 15. Despite Trustee's constant assurance that there is not enough money in
25 the trust account for moving my mother to a health care facility, I received a letter from
26 Trustee's former attorney, Jeanne Kvale, dated May 23, 2022, in which she writes,
27 "there are adequate current trust assets to provide for [Grantor's] health and support
28 needs for the foreseeable future." A true and correct copy of this letter is attached

1 hereto as Exhibit 11.

2 16. I wrote a letter to Ms. Kvale on May 27, 2022 telling her about the
3 November 1, 2021 telephone discussion I had with Trustee in which he discussed my
4 mother's declining health and his refusal to provide any information regarding the trust
5 account, among other things. A true and correct copy of this letter is attached hereto
6 as Exhibit 12.

7 17. On May 30, 2022, my mother rescinded my power of attorney. I never
8 received or even saw the documents I requested from Trustee. He and his lawyer
9 used the revocation of my power of attorney to deny my requests for documents which
10 I had been seeking for many years.

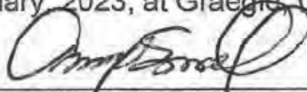
11 18. On May 31, 2022, I notified Ms. Kvale via letter of my mother's accident
12 on March 6, 2022, resulting in injuries. A true and correct copy of the May 31 letter is
13 attached hereto as Exhibit 13.

14 19. My letter to Ms. Kvale dated May 27 (Ex. 12 herein) included a spoliation
15 of data request. I also sent a spoliation of data letter to Trustee's new counsel,
16 Aleksander Shilbach, on July 6, 2022. A true and correct copy of that letter is attached
17 hereto as Exhibit 14.

18 20. My mother provided me with copies of letters she e-mailed and wrote to
19 Trustee in which she requests that he cease using her trust funds to pay for his legal
20 fees, and also requested copies of all legal bills from his previous attorney, Ms. Kvale,
21 and his current counsel, Mr. Schilbach. This letter was also e-mailed to Ms. Kvale and
22 Mr. Schilbach. There was no response from Trustee, Ms. Kvale nor Mr. Schilbach. A
23 true and correct copy of this e-mail is attached hereto as Exhibit 15.

24 I declare under penalty of perjury under the laws of the State of Washington
25 that the foregoing is true and correct to the best of my knowledge.

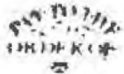

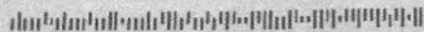

The intent of this letter is to request a full accounting of The Sharon M. Harold Irrevocable Trust dated 11/12/2004 for the sole purpose of establishing an end-of-life plan for my mother, Sharon M. Harold so the financial burden does not fall to all or any of her children, of which many cannot afford. Therefore, I need to have a complete & transparent accounting of her finances so that quality decisions can be made on her behalf and in her best interests. In all of the years that you have been Trustee [since early 2009, according to some of my mother's paperwork], none of the Beneficiaries have received any accountings ... ever. When asked over the years for any information regarding the trust, by myself as well as some other of my siblings, you have stated that we are not entitled to that information and we have to go through our mother for it.

The controlling law of The Sharon M. Harold Irrevocable Trust dated 11/12/2004 is the state of California, as stated on page 13 in the Trust paperwork.

I. CALIFORNIA LAW

This trust has been accepted by the Trustee in the State of California, and unless otherwise provided in this instrument, or required by the laws of another state where property is situated, its validity, construction and all rights hereunder shall be governed by the laws of California. This Paragraph shall apply regardless of any change of residence of the Trustee or any beneficiary, or appointment or substitution of a Trustee residing in another state.

According to California Probate Code sec. § 16062, the Trustee is required to render accounts at least annually for any trusts created after June 30, 1987.



Therefore, I am requesting all documents from each year that they have not been provided, per the above stated code. The documents I am requesting include, but are not limited to, those listed below:

- Account Statements
 - Including those showing the Principal Balance of the trust the day you became Trustee and what the Principal Balance is as of the most recent statement.
 - ALL movements of any monies to and from the trust. This includes:
 - Wire/Electronic Transfers of funds to all /any accounts. I know for a fact that my mother's monthly distribution goes into her USAA account of which she is the ONLY owner of and it has no co-signers. This is the only account that her distributions should be going into and directly from the trust account. If any funds have ever or are currently being transferred into or from any account(s) other than the two stated above, I am requesting the Institution name, account number(s), owner(s) &/or co-signer(s) on those accounts so it can be validated that no trust laws have been, or are currently, being violated according to:
 - California Probate Code § PC 16062-16069
 - Checks - copies of all checks written, accompanied by all supporting documentation such as a bill or ledger stating the purpose for the check.
- Person(s) and Company(ies), Corporations(s) or Firm(s) [current & prior] making the trust investments along with all of their business contact information; job titles, phone numbers, emails, etc. This includes any employees of BECU and its affiliates that have been involved in the management or investments of the trust in any way.
- All investment statements showing gains, losses, dividends, etc. In other words the Trusts Income.
- Trust tax documents
- Charitable donations - this includes all organizations whether non-profit or otherwise, businesses, personal investments or contributions, personal gifts or school tuitions and anything else that my mother has considered 'charitable'.
- Miscellaneous - Lien holds, loans (personal or business) for anyone regardless of relationship, any monies distributed to Sharon or anyone else that is outside of Sharon's standard and regular monthly distribution to be accompanied by a ledger or other documentation stating the reason why the additional funds were needed &/or requested with any applicable receipts, etc.

Over the past few months my mother has been in & out of the emergency room at least 2-3 times. She is a danger to herself and continues to decline. Decisions need to be made quickly and it is impossible to do any proper planning without knowledge of what the trust can afford for my mother's care.

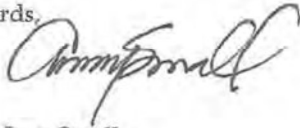
Thank you in advance for your urgent attention & prompt response to this request.

Dear Ms. Kvale,

On November 1, 2021 @ 4:44pm I received a phone call from David Paice that lasted for a total of 26 minutes. David stated that he was calling because he was very concerned about my mother, Sharon M. Harold's current mental state and capabilities. His concerns went from my mom being unable to remember simple things to verbally combative behavior.

One example David gave was he provided additional funds to Sharon she claimed he never sent the money and she never received it. Another example was more extreme. Mom constantly requested additional funds for unnecessary items such as mattresses, recliners, etc. all which she had purchased multiple times, over a short period of time. David said she kept returning items over and over again, spending more money because she was never happy with any of her purchases.

I told David to simply say no and not provide additional funds for such unnecessary items. David replied that if he doesn't give her the money, Sharon becomes hostile, harassing, persistent & sends never-ending texts and voicemails, almost to a point of verbally abusive behavior. He stated that he would prefer not to continue to be Trustee. I suggested to David that if he feels that way, he should simply tell Sharon that he would like to resign as Trustee, as that is his right. To date, David has done no such thing even though he personally told me that he no longer wanted the responsibility.

I asked David why he was calling me about this. David stated that he was calling me specifically due me being Sharon's Power of Attorney. He stated that he wasn't sure how to handle her, was concerned about her progressing mental decline and her inability to manage her own affairs.

I explained to David that my mother had made it very clear to me over the past few years, since she appointed me Power of Attorney on June 21st, 2018, that she had no desire to reside with any of her children or grandchildren and would like to go into a care facility. I told her I would help her look for something that met her current needs and would be able to accommodate a transition to assisted care as well if that ever became necessary. I explained to David that I would not consider any care facilities for my mother that were less than \$5,500 per month, as the research I did to date appeared that anything less would be subpar care.

David stated immediately that my mother's trust did not have enough money to support that sort of monthly payment for her care. I found that statement to be of concern and quite alarming to be frank. I said, "What do you mean there is not enough money for that? What is the balance of the Trust?" David replied, "I can't tell you that". I reminded him that I have P.O.A so I believe I am entitled to know that. David stated that if I wanted to know that information, I would have to ask my mother. To recap; David wanted me to get the information from my mother, even though he just told me 20 minutes prior that he was concerned her mental state was in decline. (This was the whole point of my request for an accounting on May 27th, 2022).

In addition, my mother has told me personally and most of my other siblings, that she and David have a joint bank account. David himself told 1 or more of my other siblings that he transfers from 3-6 months of distributions into that account at one time, because "It's easier to pay your mother that way." David has also told other family members that his 'boss' at the credit union where he works 'advises' him about 'investments' for my mothers' money. Isn't this a conflict of interest?

On Wednesday May 4th, 2022 @ 11:47am I spoke to my mother for 15 minutes. She thanked me for requesting a full accounting of the Trust and stated that all she ever gets from David are the occasional investment statements, which as you are aware are only snapshots in time of account balances, not an accounting as required by California law. Mom stated that for the past couple of years she has asked David specifically for the banking documents for the Trusts account as well as the joint one she and David have together. My mother stated during the conversation that David had not, to date, provided them to her as she had requested.

My mother has taken David and his family on vacations and fully paid for them with money from the Trust. A couple of examples are a trip to Canada and a trip to Disneyland of which each trip was an approximate cost in the ballpark of \$10,000 each.

As you can see, we have a reasonable dispute about the state of my mother's finances, her trust and her mental health.

In order for both us to make a fair, impartial and accurate calculation of her trust and mental state, at some point I will need to analyze the records that reside on the various computer systems that are under David's control and the control of his various co-workers. Taking the words of my mother

with impaired mental ability is not going to get to the facts of the matter. Math is math and that is all we need here to know what is going on.

I have records that I need to prove my demands, but I do not have all of the records. David has some records, his employers have some records and your firm no doubt has some. I have first-hand knowledge of this because of what David has told me and other family members personally, and I have seen limited documents about my mother's investments.

While I am hopeful that we can resolve this dispute, it does not seem likely since David has failed to provide this information to my mother. It is also unlikely we can resolve this matter amicably because of the overwhelming and objective evidence that my mother's memory is poor at best and therefore her mental capacity makes her incapable of making rational decisions about her well-being. This is exactly why she appointed me her power of attorney; so, when this day came, I could provide her the care she needs. That day has arrived.

Therefore, anticipating a third-party resolution, you have an obligation under the law to preserve evidence and prevent the spoilation of the data in question.

The data and information I am asking be preserved will protect my mother's interest, David's interest, the interest of his employer and your firm's interest as well and may in fact lend credibility to your recent claims that the trust finances have enough monies to pay for my mother's declining health issues.

If she claims to be of sound mind with no limits to her mental state, then the only other answer would be that she is not being honest in her claims of not knowing.
 2. Most concerning was my mother's comment that she is going to need any monies from the house for her future care. If the Trust has plenty of money to support my mother's care of which her and David are now claiming (which is in direct contrast to what David told me over the phone on November 1, 2021) why is she concerned about needing that money(ies) to take care of herself?

My brother John reached out to me on Friday evening with this information as a concern for my mother's well-being. As she made comments that claimed she had no idea of changes she herself made and my brother also was aware of those changes, because she had told him previously. His concern is that our moms memory is continuing to decline.

I believe it is important for you to know that though my mother is very aware of my brother's condition and that it will continually get worse and he will eventually die from it, she still calls him when she has an emergency. Not sure how familiar you are with his condition (M.S.A) but if you know anything about Parkinson's, it is similar. The main difference is that where Parkinson's has to do with ones nerves, M.S.A has to do with ones mucle (ALL muscles such as legs, arms, tongue,

swallowing, etc.). The point being that he already has trouble swallowing, walking, writing, standing, bending over and can no longer play the piano, talk, write, etc, and will only continue to worsen he is already disabled and barely able to care for himself yet she calls him in an emergency rather than 911.

On Sunday March 6, 2022 @ 4:36pm I received a text message from my brother, John, with a picture of a lot of blood on what appeared to be a floor. When I asked what happened, John stated that he received a call from my mother stating that she has fallen and could not get up and asked him to come over and help her. Upon arrival my brother found my mother on the kitchen floor covered in blood with a 4" to 5" gash on her skull. Being disabled and barely having enough muscles to sustain himself, he could be of absolutely no help to getting her off of the floor. The best he could do was stand there and watch her figure out how to struggle to get off the floor and drive her to the hospital once she got up. This was a horrible accident and had it been any worse my mother may not have survived because my brother cannot be of any physical assistance to her nor can he really explain what was happening had he needed to call 911 due to his difficulty of speech because of his condition. The point to this is that my mother had taken a very bad fall, was laying in a pool of her own blood, knew that my brother is disabled and can be of no assistance yet chooses to call him rather than 911 as she lay surrounded by blood with her skull exposed and blood running down her face. She had no forethought that this was a real emergency. No person in their right mind would have made the decision my mother did. This is highly concerning. 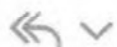

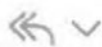

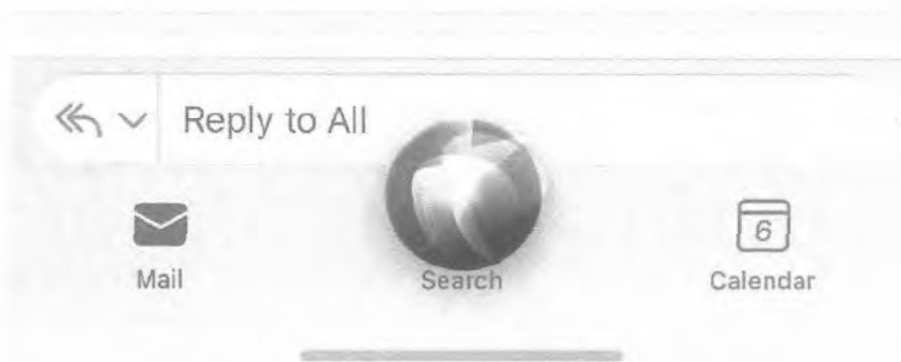

The main reason for the Trust is for my mother and her care and now that she has retained an attorney and is paying for David's representation she will not be afforded the end of life care that she so rightfully deserves because it will all be sucked up on legal fees. Once again, my goal is the same as it has always been which is to get a full accounting of the Trust so that decisions can be made for my mother's care. That is all this has ever been about.

Mr. Schilbach,

Based on the letter from you dated June 10, 2022, it appears that you may have only been provided the initial letter dated April 27, 2022 that I sent directly to David Paice, requesting a full accounting of my mother's trust. I believe this to be the case based on some of your comments. Please thoroughly read and review all attached material and prior communication to Ms. Kvale, so you have a full understanding other than the limited information you have only been given.

There is and has been no threat to the Trustee or his employer. As you can see in prior communication to Ms. Kvale, I had requested preservation of data. I simply requested preservation of data in writing to Ms. Kvale, as David's attorney at the time.

As you can see in the attachments, on May 31, 2022, David communicated with me directly (during the time Ms. Kvale was his attorney) and sent me supposed accountings of the trust. You will also see that I replied that he should not be communicating directly with me and I would not open the document unless and until Ms. Kvale acknowledged that she was aware of his correspondence with me.

On June 7, 2022 I received a letter from Ms. Kvale informing me that she was no longer representing my mother or David. Only at that time did I reach out to David directly and attempt to open his documents. I simply made a statement reminding him that I would most likely have to request the preservation of data since he no longer had an attorney.

Now that you made me aware as of on June 10, 2022 that you are representing David, I will make the same request to preserve data to you that I had done so of his prior attorney.

As you can see, we have a reasonable dispute about the state of my mother's finances and her mental health.

In order for both of us to make a fair, impartial and accurate calculation of her trust and mental state, at some point I will need to analyze the records that reside on the various computer

systems that are under David's control and the control of his various co-workers. Taking the words of my mother, with impaired mental ability, is not going to get to the facts of the matter.

I have records that I need to prove my demands, but I do not have all of the records. David has some records and his employer has some records. I have first-hand knowledge of this because of what David has told me and other family members personally, and I have seen limited documents about my mother's investments.

While I am hopeful that we can resolve this dispute, it does not seem likely since David has failed to provide my mother any proper accounting(s) over the years, as required by the trust document as well as per my mother's own statement to me. It is also unlikely we can resolve this matter amicably because of the overwhelming and objective evidence that my mother's memory is poor at best and therefore her mental capacity makes her incapable of making rational decisions about her well-being. This is exactly why she appointed me her Power of Attorney; so when this day came, I could provide her the care she needs. That day has arrived.

The data and information I am requesting to be preserved will protect my mother's interest, David's interest, the interest of his employer and your firm's interest as well and may in fact lend credibility to David's recent claims that the trust finances have enough funds to pay for my mother's declining health issues.

Therefore, in anticipation of the possibility that we cannot resolve this dispute and that the accounting that is being worked on will not include everything exactly as I requested in my letter dated April 27, 2022 and may need to seek third-party resolution; in the interest of fairness, please immediately and without delay preserve evidence and prevent the spoliation of the following data files and sources, including any deleted data files.

16. All receipts documenting money paid and spent, including labor and materials pertaining to David's wife Brieana's home remodeling business, registered in Washington State as BEK Bath And Kitchen, Llc, Filing Number #604803913.

As you know, my request to preserve evidence has nothing to do with the current status of my Power of Attorney, therefore, excluding any other demands you may disagree with, you are required as an officer of the court to proceed with my request to preserve evidence.

I assume the accountant you are using is David Llewellyn. I sent him my accounting request, dated April 27, 2022, and all of my Power of Attorney paperwork in May. David Llewellyn stated that he had requested all 12 years of banking statements from David Paice to complete the accounting, as per my specific requests. If my request is already being handled by the trust accountant and the trust will pay for that accounting, why does David Paice need an attorney?

If David chooses to retain you for whatever reason, my mother's trust will not be paying for that. I am directing you to stop billing my mother's trust for your services. I am not approving your fees.

Any fees pertaining to your representation of David Paice should be paid directly from David Paice's personal finances or through his Trustee Errors & Omissions Insurance. If David has not obtained E & O Insurance, it is not the responsibility of my mother nor her trust to pay for you to represent him. I do not approve this. If you continue to bill the trust for your services to represent David, I will contest those charges in court and seek reimbursement for any charges already incurred.

In closing, your firm and David are billing my mother's estate, using up what little money she has left (according to your client). Your firm and David are knowingly billing an elderly woman with known mental, memory and physical limitations (as stated to me by your own client). My mother is asking for the legally required estate/trust accounting, through me with power of attorney. I am not understanding why providing the accountings have taken so long. Surely there should be previous years accountings, as required per the trust document, that should be readily available. Has David failed to do any accounting for 12 years as he is required to provide in both law and as the fiduciary? You and your firm are therefore defending David, my mother's own Trustee, against who, herself?
