This matter came before the Court on the motion of attorney Michelle A. Blackwell for an order authorizing her withdrawal as attorney of record for Respondent Sharon Harold. The Court considered the pleadings filed in this action, the declaration of Michelle A. Blackwell, and the following evidence: Withdrawal is sought by a retained attorney in a civil case, and the parties' written, signed representation agreement allows the representation to be terminated at any time by them. The attorney-client relationship is consensual, and Sharon Harold's desire to quit it should be given great weight. Good cause has been demonstrated to allow the withdrawal.

Based on the argument, pleadings and evidence presented, the Court overrules the Interested Persons' objection to the withdrawal and finds that withdrawal of Michelle A. Blackwell as attorney for Sharon Harold is appropriate for the reasons stated above.
