DECLARATION OF CHARLES A.

I, Charles A. Harold, Jr. declare as follows:

a Trust.

- 1. I am a Residual Beneficiary of the Sharon M. Harold Irrevocable Trust dated November 12, 2004 ("Trust"). I also have power of attorney for Sharon M. Harold along with my sister Amy Jane Small, and we are attorneys-in-fact for her as well. I have personal knowledge of the facts set forth herein. I make this declaration in support of the Opposition to Motion of Petitioner for Appointment of a Litigation Guardian ad Litem for Sharon M. Harold.
- 2. While preparing this opposition, I researched applicable California Probate Codes. Attached hereto as Exhibit 1 is a true and correct copy of California Probate Code § 1060 *et seq* downloaded from the California Legislative Information website.
- 3. When the idea of appointing a litigation guardian ad litem was first brought up at the February 3 hearing, my mother became upset and wrote a letter in

response. I was copied on that letter. A true and correct of that letter with attachments which I received via e-mail is attached hereto as Exhibit 2.

- 4. As part of my investigation as requested by my mother and with her permission, I downloaded her phone calls, texts and usage records from her AT&T account for the following phone number: (541) 662-1937. This is my mother's phone number which she has had for many years. The records are from a physical phone she has had since October 13, 2021. The records were saved in Excel format, and then I imported them into a Microsoft Access database. Inside Access, I set up a database table by named fields assigning categories.
- 5. I accessed my mother's contact list and using that information I identified the owners of various phone numbers in the database. For other phone numbers, I used Google and public record databases to identify the owners of those numbers and entered them in the "CallerID" field. I then updated the CallerID field of the Access database with as many phone numbers I could identify.
- 6. That table of phone numbers was exported to Microsoft Excel. I then reviewed multiple e-mails and other documents and inserted references to those emails and documents chronologically into the Excel spreadsheet. This created a timeline of events where a viewer could see text messages and phone calls corresponding with various actors within this litigation. The resulting report is attached hereto as Exhibit 3.

PART 1. GENERAL PROVISIONS [1000 - 1064] (Part 1 enacted by Stats. 1990, Ch. 79.)

CHAPTER 4. Accounts [1060 - 1064] (Chapter 4 added by Stats. 1996, Ch. 862, Sec. 4.)

1060. This chapter governs all accounts to be filed with the court. Except as specifically provided elsewhere in this code, or unless good cause is shown therefore, no information in addition to that required in this chapter need be in an account.

(Amended by Stats. 1997, Ch. 724, Sec. 5. Effective January 1, 1998.)

1060.5. This chapter shall be operative on and after July 1, 1997.

(Added by Stats. 1996, Ch. 862, Sec. 4. Effective January 1, 1997. Note: This section prescribes a delayed operative date (July 1, 1997) for Chapter 4, commencing with Section 1060.)

- 1061. (a) All accounts shall state the period covered by the account and contain a summary showing all of the following, to the extent applicable:
 - (1) The property on hand at the beginning of the period covered by the account, which shall be the value of the property initially received by the fiduciary if this is the first account, and shall be the property on hand at the end of the prior account if this is a subsequent account.
 - (2) The value of any assets received during the period of the accounting which are not assets on hand as of the commencement of the administration of an estate.
 - (3) The amount of any receipts of income or principal, excluding items listed under paragraphs (1) and (2) or receipts from a trade or business.
 - (4) Net income from a trade or business.
 - (5) Gains on sales.
 - (6) The amount of disbursements, excluding disbursements for a trade or business or distributions.
 - (7) Loss on sales.
 - (8) Net loss from trade or business.
 - (9) Distributions to beneficiaries, the ward or conservatee.
 - (10) Property on hand at the end of the accounting period, stated at its carry value.
- (b) The summary shall be in a format substantially the same as the following, except that inapplicable categories need not be shown:

Nothing in this section is intended to require that the preparation of the summary must include "net income" and "net loss" as reflected in the tax returns governing the period of the account. (Amended by Stats. 1997, Ch. 724, Sec. 6. Effective January 1, 1998.)

1062. The summary shall be supported by detailed schedules showing the following:

- (a) Receipts, showing the nature or purpose of each item, the source of the receipt, and the date thereof.
- (b) Disbursement, including the nature or purpose of each item, the name of the payee, and the date thereof.
- (c) Net income or loss from a trade or business, which shall be sufficient if it provides the information disclosed on Schedule C or F of the federal income tax return.
- (d) Calculation of gains or losses on sale or other disposition.
- (e) Distributions of cash or property to beneficiaries, ward or conservatee, showing the date and amount of each, with the distribution of property shown at its carry value.
- (f) Itemized list of property on hand, describing each item at its carry value.

(Added by Stats. 1996, Ch. 862, Sec. 4. Effective January 1, 1997. Section operative July 1, 1997, pursuant to Section 1060.5.)

1063. (a) In all accounts, there shall be an additional schedule showing the estimated market value of the assets on hand as of the end of the accounting period, and a schedule of the estimated market value of the assets on hand as of the beginning of the accounting period for all accounts subsequent to the initial account. The requirement of an estimated value of real estate, a closely held business, or other assets without a ready market, may be satisfied by a good faith estimate by the fiduciary.

- (b) If there were purchases or other changes in the form of assets occurring during the period of the account, there shall be a schedule showing these transactions. However, no reporting is required for transfers between cash or accounts in a financial institution or money market mutual funds as defined in subdivision (d) of Section 8901.
- (c) If an estate of a decedent or a trust will be distributed to an income beneficiary, there shall be a schedule showing an allocation of receipts and disbursements between principal and income.
- (d) If there is specifically devised property, there shall be an additional schedule accounting for income, disbursements, and proceeds of sale pursuant to Section 12002 and subdivision (a) of Section 16340.
- (e) If any interest has been paid or is to be paid under Section 12003, 12004, or 12005, or subdivision (b) of Section 16340, there shall be a schedule showing the calculation of the interest.
- (f) If the accounting contemplates a proposed distribution, there shall be a schedule setting forth the proposed distribution, including the allocation of income required under Section 12006. If the distribution requires an allocation between trusts, the allocation shall be set forth on the schedule, unless the allocation is to be made by a trustee after receipt of the assets. If the distribution requires valuation of assets as of the date of distribution, the schedule shall set forth the fair market value of those assets.
- (g) If, at the end of the accounting period, there are liabilities of the estate or trust, except current or future periodic payments, including rent, salaries, utilities, or other recurring expenses, there shall be a schedule showing all of the following:
 - (1) All liabilities which are a lien on estate or trust assets.
 - (2) Taxes due but unpaid as shown on filed returns or assessments received subsequent to filing of returns.
 - (3) All notes payable.
 - (4) Any judgments for which the estate or trust is liable.
 - (5) Any other material liability.
- (h) If the guardian or conservator has knowledge of any real property of the conservatee or ward located in a foreign jurisdiction, the guardian or conservator shall include an additional schedule that identifies the real property, provides a good faith estimate of the fair market value of the real property, and states what action, if any, will or has been taken to preserve and protect the real property, including a recommendation whether an ancillary proceeding is necessary to preserve and protect the real property.

(Amended by Stats. 2008, Ch. 52, Sec. 1. Effective January 1, 2009.)

- <u>1064.</u> (a) The petition for approval of the account or a report accompanying the petition shall contain all of the following:
 - (1) A description of all sales, purchases, changes in the form of assets, or other transactions occurring during the period of the account that are not otherwise readily understandable from the schedule.
 - (2) An explanation of any unusual items appearing in the account.
 - (3) A statement of all compensation paid from the assets subject to the account to the fiduciary or to the attorneys for the fiduciary other than pursuant to a prior court order.
 - (4) A statement disclosing any family or affiliate relationship between the fiduciary and any agent hired by the fiduciary during the accounting period.
 - (5) An allegation disclosing whether all of the cash has been invested and maintained in interest bearing accounts or in investments authorized by law or the governing instrument, except for an amount of cash that is reasonably necessary for the orderly administration of the estate.
- (b) The filing of an account shall be deemed to include a petition requesting its approval, and may include additional petitions for authorization, instruction or confirmation authorized by the code, including, but not limited to, a request for an order for compensation of the fiduciary and the attorney for the fiduciary.
- (c) For purposes of this section, "family" means a relationship created by blood or marriage. For purposes of this section, "affiliate" means an entity that directly or indirectly through one or more intermediaries controls, is controlled by, or is under common control with, the fiduciary.

Regarding my letter to David Paice on 24 Feb 2023 & your letter to me below.

Again, on 24 Feb 2023, I emailed David Paice a request for funds to pay off my credit cards and a bill for dental work to be done. The funds for Attorney Ms. Blackwell was charged to my credit card due to lack of trust funds refused to me by David Paice, my Trustee.

The purpose of writing JUST to David personally, (I now have no council, as you well know) was so that I did not aquire more of your attorney fees against my trust.

What do I get in return, Mr Schilbach? An email from YOU which created MORE attorney fees against the Sharon M, Harold Trust! And why does David need an attorney in the first place if he did nothing wrong?

I do not intend to wait 1 more day, much less 1 more week, as you state in your email below, for the funds to be sent by check when David is capable of sending them thru Zelle as he has done in the past. That way I receive funds in a matter of minutes. I want the money I asked him for deposited to my checking account immediately. And to that sum you can add another \$30,000.00 I will be needing for transportation, lodging, medical bills & after-care for a forthcoming eye surgery due to "Invassive Squamos Cell Carcinoma" of my right eyelid. I was diagnosed with this malady on Monday, 27 Febuary 2023, as a result of a biopsy done the previous month.

In addition to the above I request, again, \$100,000.00 for attorney fees from MY trust for MY benefit which I have been refused me for the past 4 or 5 months. For some unimmaginable reason David is allowed to charge MY trust at LEAST \$100,000.00 for the 2 attorneys he has hired but I am refused money to accomodate myself. Instead you and David want the court to appoint a Guardium ad Litum for me. I do NOT NEED, WANT and ADAMENTLY REFUSE a LGAL, In case you have not figured it out yet, I am perfecty capable of speaking for myself and with an attorney. How can you and David possibly justify your expenditures? And to reiterate, "Why does David need a attorney in the first place if he has done nothing wrong? The first attorney David & I had was one of my choosing, Jeanne Kavel of Hathaway Law Firm in Ventura, CA. However, Jeanne dismissed us, rightfully so, for "Conflict of Interest." I do believe she became aware there was something "Rotten in Denmark" after sometime speaking with David and me. I believe she saw through David long before I did! I believe, Sir you have been misinformed on many issues.

The claim that "the trustee has refused to make distributions" is mostly true. David has given me my monthly income of \$2500 with regularity, on time, and a bit more money if needed. However I would not call \$30-\$35,000 annually a huge sum. I moved to Oregon to save money to leave to my now living children. Looks like that's not working out too well the way you and David are spending it. I do believe you are in trouble, Sir.

My second attorney Ms. Michelle Blackwell dropped my council when I could not come up the another \$10,000 retainer fee because my trustee Mr. Paice did not give me any attorney fees to begin with when asked for and consequently I had maxed out my credit cards to about to at least \$20,000. And in your email, as to Ms. Blackwell being "Informed" to a "non waivable conflict of interest" as well as "important information regarding my physical and mental health" I have the following to say.

As to 06 March 2022, the 9 inch split in my head (crown to right eyebrow) that required 22 staples and 20 stitches, it has healed well, with few problems. As to my mental health, I had an evaluation done by my Neurologist with an accompaning assistan present, on 1 June 2022 that states for a woman of 84 yrs old and considering what I have been through, I am doing quite well. Encolsed is a document from my Neurologist who I have used for many years. You also state in yor email' that "Mr. Paice remains concerned about my well-being" If Mr Paice was concerned about my well-being he would not be spending MY trust money for his giant attorney fees. Instead he would be giving me money for my representation and be providing me money for a care facility which was requested for me some years back. Instead of telling my children, before witnesses, that "there is not enough money for a care facility for Sharon".

According to my BECU Investment statement Year Ending 2022 from LPL, on 1 January 2022 my trust had \$706,585.00 On 31 December 2022 the value had dropped to \$522,722.00. Considering that I only receive \$30,000 to \$35,000 per year, where did the rest of the money go? Attorney fees? Obviously not in my pocket or for MY care. For as long as this trust has been in existance it should be worth close to \$1,000,000,00

As for the accusation of my "children taking advantage of me" I will tell you that my children, especially, Amy Jane and Charly, and also Josette (Joie), have paid bills for me and given me huge emotional support as well as financial help.

And speaking of BECU, in about 2020 or 2021, I personally called Brian Locke who handles the investments for the Sharon M. Harold Trust and told him to cash out 3 or 4 investments and reinvest the money more wisely as those investments had been losing money for close to 4 years. Mr. Locke did so after telling me that basically "just because the Gain/Loss column shows a minus sign it does not necessisarily mean it is losing money." Brian must have learned a different math than I did.

The follow year after the reinvesting, my trust grew by \$100,000.00. It was David who told me to call Brian because David said he "had nothing to do with the investments." David is trustee of MY money. David told me he has nothing to DO with my money? I don't get it. He sure knows how to spend it. Then in 2022 I received virtually no statements sent to my house except for the 2022 End of Year statement from LPL. That statement that showed Brian Locke AGAIN reinvested the very same companies I told hin to remove, which AGAIN showed a minus sign in the Gain/Loss column.

To date, I have not received confirmation of the email that I sent to you on October 5, 2022 notifying you that I revoke my release of the Release and Discharge of Successor Trustee document. I have also sent 2 subsequent emails requesting confirmation on October 6 and October 7, 2022 with no response. Therefore, I am now taking further steps to verify the accounting by having a forensic accounting done on all my accounts.

During the accounting and until further notice, I am limiting David Paice's trustee duties and authority as follows.

- 1. David Paice shall stop using my trust money to pay his attorney fees. I do not approve any attorney fees to be billed to or paid from my Trust during my review. 

- 4. David Paice shall direct any/all persons making investment decisions, transferring money, or doing anything regarding the money in any of my bank accounts or investment accounts until further notice by me. No changes are to be made to any of my investments. I will contact Brian if and when I choose to make any changes.
- David Paice shall stop talking to or corresponding with anyone about the status or management of my trust including David's employer, investment account managers, fund managers, attorneys, friends or family.

David Paice and his attorney(s) and Lane Powell employees shall fully cooperate with David Llewellyn and provide him with any information he needs about my trust, including bank account and investment fund information. As Grantor of the Sharon M. Harold Irrevocable Trust, I have asked you on numerous occasions to stop spending trust money on attorney fees. I hope what you are spending is coming out of your pocket and not my above named trust. I have asked you several times for fees for an attorney to represent me and no funds were forthcoming. After exhausting all my credit cards on attorney fees, my attorney resigned because I could not come up with another \$10.000 retainer fee.

I have asked for an accounting of expences, checks and check registers, etc for my trust, none of which were forthcoming since 2010. In 2019 or 2020 I asked you to cash out some investments and you told me to call Brian Locke and tell him to do it because you had nothing to do with investments.

Therefore I called Brian Locke and told him to cash out 3 or 4 investments (including FEIAX & FSTAX) that showed a minus sign in the "Unrealized Gain/Loss (\$)" column. 
